

RESOLUTION

WHEREAS, pursuant to Nebraska Statute 32-553(1), R.S. Reissue May 2021, "When any political subdivision except a public power district nominates or elects members of the governing board by districts, such districts shall be substantially equal in population as determined by the most recent federal decennial census." And

WHEREAS, the 2020 census block data has been received by Scotts Bluff County and the Scotts Bluff County Attorney has reviewed the boundary changes proposed herewith for the five Scotts Bluff County Commissioner districts;

NOW THEREFORE BE IT RESOLVED that the boundaries of the five Scotts Bluff County Commissioner Districts shall be established as follows:

Commissioner District I shall include all of existing Castle Rock A, Castle Rock B, Dewey-Tabor, East Winter Creek, Funston, Gering-Roubadeau lying east of a line described as: Beginning at the SW corner of Section 14, T20, R56, then North to the NW corner of Section 11, T20, R56, then East to the NE corner of Section 12, T20, R56, then North to the NE corner of Section 1, T20, R56, then East to the SE corner of Section 32, T21, R55, then North to the NE corner of Section 5, T21, R55, Gering IV (as defined by the City of Gering Ordinance No. 2019 dated December 13, 2021), Highland and Minatare I & II precincts;

Commissioner District II shall include all of existing Fanning, Ford A & B, Gering-Roubadeau lying west of a line described as: Beginning at the SW corner of Section 14, T20, R56, then North to the NW corner of Section 11, T20, R56, then East to the NE corner of Section 12, T20, R56, then North to the NE corner of Section 1, T20, R56, then East to the SE corner of Section 32, T21, R55, then North to the NE corner of Section 5, T21, R55, Kiowa-Lyman, Mitchell (Rural), Mitchell I, Mitchell II, Morrill and West Winter Creek precincts;

Commissioner District III shall include Gering I precinct (as defined by the City of Gering Ordinance No. 2019 dated December 13, 2021), Gering II precinct (as defined by the City of Gering Ordinance No. 2019 dated December 13, 2021), Gering III precinct (as defined by the City of Gering Ordinance No. 2019 dated December 13, 2021), and existing Terrytown I & II precinct;

Commissioner District IV shall include all of existing Scottsbluff 3, Scottsbluff 4, Scottsbluff 5, Scottsbluff 6 precincts (as defined by the City of Scottsbluff Ordinance No. 4267 dated November 15, 2021);

Commissioner District V shall include all of existing Scottsbluff 1, Scottsbluff 2, Scottsbluff 7 and Scottsbluff 8 precincts (as defined by the City of Scottsbluff Ordinance No. 4267 dated November 15, 2021).
