RFPs - Bids - Contracts Awarded 2012

Roads Dept - Box Culvert - January 17, 2012

Box culvert bids were received and opened by Robert Bennett, Public Works Director on January 10, 2012. Bids were received from: Simon Construction, Scottsbluff - \$266,181.20; Paul Reed Construction, Gering - \$277,043.09; Infinity Construction, Scottsbluff - \$157,835.00. The Bids were tabulated and presented at the County Commissioner meeting on January 17, 2012. **The Bid was awarded to Infinity Construction, Scottsbluff, for \$157,835.00 as recommended by Road Department Director Robert Bennett.**

Tourism Dept - Tourism Office - March 19, 2012
