

I, KENNETH GEORGE ROBERTS, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that on the 11th day of February, 1961, I completed a survey of Lots Nine (9) and Ten (10), Block Two (2), Northeast Addition to the City of Scottsbluff, Nebraska, and the Avenue adjoining thereto on the West, all situated on a part of the Southwest Quarter (5W4) of the Northwest Quarter (NW4) of Section Twenty-four (24), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th Principal Meridian in Scotts Bluff County, Nebraska, more particularly described as follows:

Beginning at a point on the West line and 853.0 feet North of the SW Corner of the SW4 NW4 Sec. 24; said point being located 33 feet West and 160 feet North of the NW Corner of Block One (1), Northeast Addition to the City of Scottsbluff, Nebrasla; thence North along the West line of the SW4NW4 Sec. 24, for a distance of 180 feet; thence East and parallel to the North of said Block One (1), Northeast Addition, for a distance of 185:25 feet; thence South and parallel to the West line of said SW4NW4 Sec. 24, for a distance of 280.0 feet; thence West and parallel to the North line of Block One (1), Northeast Addition for a distance of 20.0 feet to the Southeast Corner of Lot Eight (8), Block Two (2), Northeast Addition; thence North along the East Line of said Lot Eight (8), a distance of 100 feet; thence West along the North Line of said Lot Eight (8), a distance of 165.25 feet to the point of beginning.

That the accompanying plat is a correct delineation of said survey drawn to a scale of 100 feet to an inch. All dimensions are shown in feet and decimals.
