

I KENNETH GEORGE ROBERTS, A COMPETENT SURVEYOR OF SCOTTSBLUFF COUNTY, NEBRASKA HEREBY CERTIFY THAT ON THE 18TH DAY OF FEBRUARY, 1962, I COMPLETED A SURVEY OF LOTS FIVE (5), SIX (6), SEVEN (7), È EIGHT (8), BLOCK THREE (3); AND LOTS EIGHT (8), NINE (9), AND TEN (10), BLOCK FOUR (4), NORTHEAST ADDITION TO THE CITY OF SCOTTSBLUFF, SCOTTSBLUFF COUNTY, NEBRASKA, AND A PART OF 21ST STREET AND 22ND STREET; AND THE ALLEY ADJOINING SAID LOTS ON THE EAST, ALL SITUATED ON A PART OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER (5W 1/2 NW 1/4) OF SECTION TWENTY FOUR (24), TOWNSHIP TWENTY TWO (22) NORTH, RANGE FIFTY FIVE (55) WEST OF THE GTH PRINCIPAL MERIDAN IN SCOTTSBLUFF COUNTY, NEBRASKA MORE PARTICULARLY DESCRIBED AS FOLLOWS;

BEGINNING AT A POINT 363.0 FEET NORTH & 369.9 FEET EAST OF THE SOUTHWEST CORNER OF SAID SW & Sec. 24; SAID POINT BEING LOCATED GO FEET EAST & 30 FEET SOUTH OF THE SOUTHEAST CORNER OF BLOCK ONE (1), NORTHEAST ADDITION TO THE CITY OF SCOTTSBLUFF, NEBRASKA; THENCE NORTH ALONG THE EAST LINE OF GTH AVENUE, A DISTANCE OF GTO.0 FEET, TO THE NORTH LINE OF LOT FIVE (5), BLOCK TWO (2), OF SAID NORTHEAST ADDITION, EXTENDED EAST; THENCE EAST ALONG THE EASTERLY EXTENSION OF SAID LOT FIVE (5), A DISTANCE OF 140.0 FEET; THENCE SOUTH AND PARALLEL TO THE EAST LINE OF SAID GTH AVENUE, A DISTANCE OF GTO.0 FEET; THENCE WEST AND PARALLEL TO THE SOUTH LINE OF SAID BLOCK ONE (1), NORTHEAST ADDITION, EXTENDED EAST, A DISTANCE OF 140.0 FEET; TO THE POINT OF BEGINNING.
