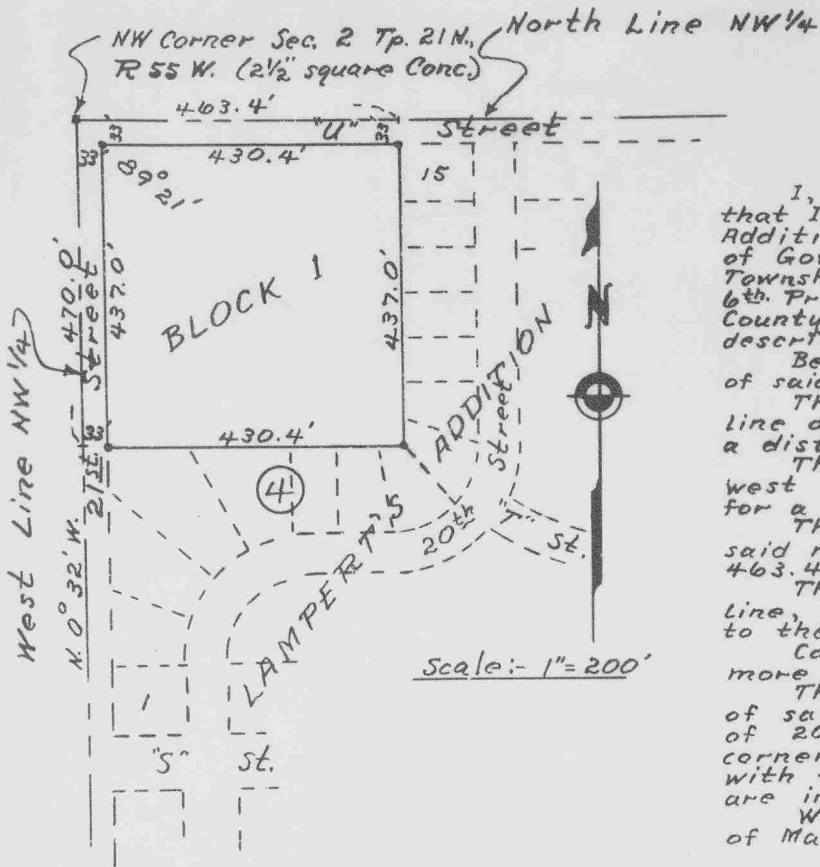

SURVEYOR'S CERTIFICATE

I, William E. Keefover, hereby certify that I have surveyed Faith Lutheran Addition to Gering, Nebraska, on part of Government Lot 4, Section 2, Township 21 North, Range 55 West of the 6th Principal Meridian, Scotts Bluff County, Nebraska, more particularly described as follows:-

Beginning at the Northwest Corner of said Section 2;
 Thence S. 89° 53' E., on the north line of said Government Lot 4, for a distance of 463.4 feet;
 Thence S. 0° 32' E., parallel with the west line of said Government Lot 4, for a distance of 470.0 feet;
 Thence N. 89° 53' W., parallel with said north line, for a distance of 463.4 feet;
 Thence N. 0° 32' W., on said west line, for a distance of 470.0 feet, to the point of beginning;

Comprising an area of 5.00 acres more or less.
 This plat is a correct delineation of said survey, drawn to the scale of 200 feet to the inch. The corners of the Block are marked with 5/8" x 48" iron rods, and dimensions are in feet and decimals.
