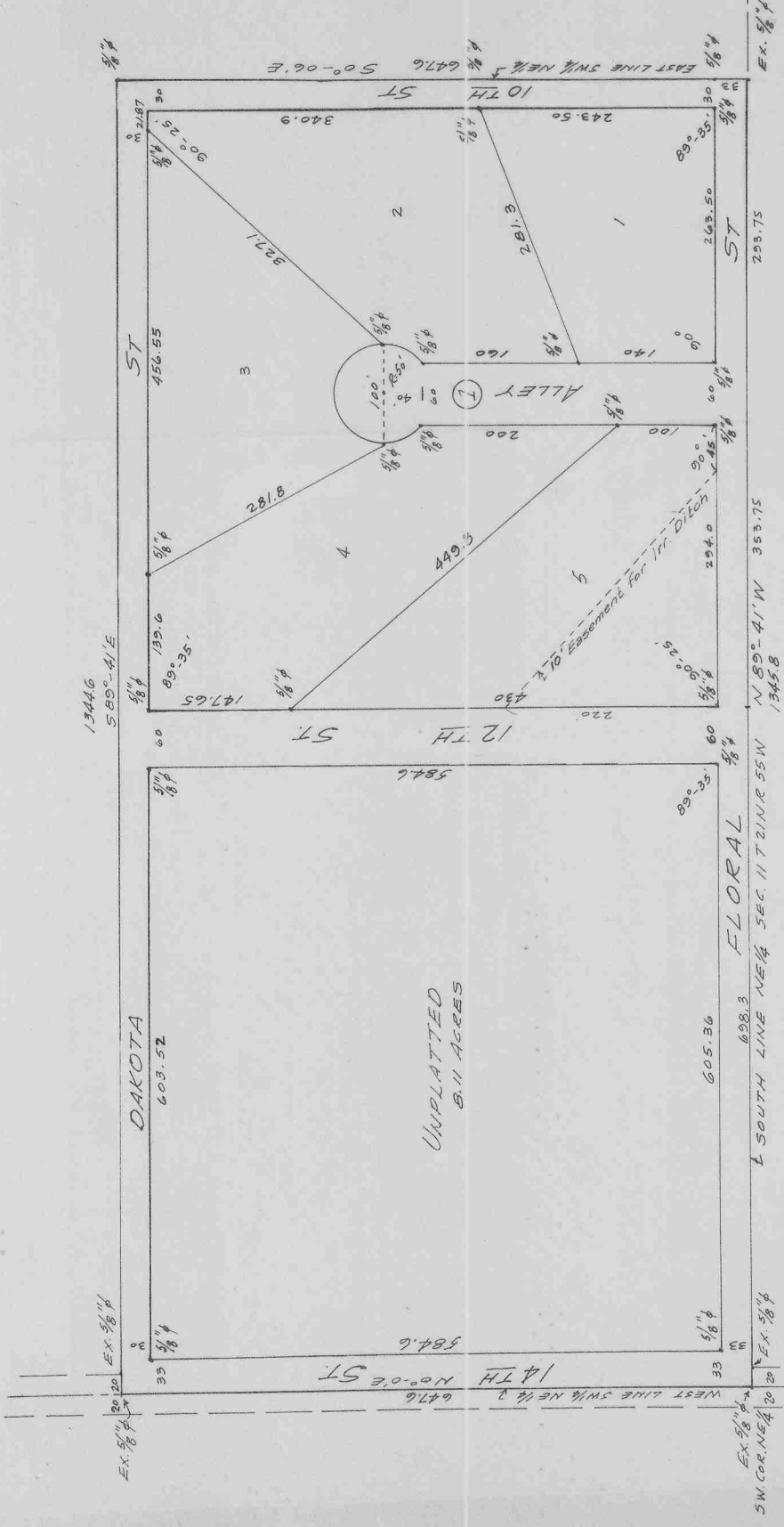

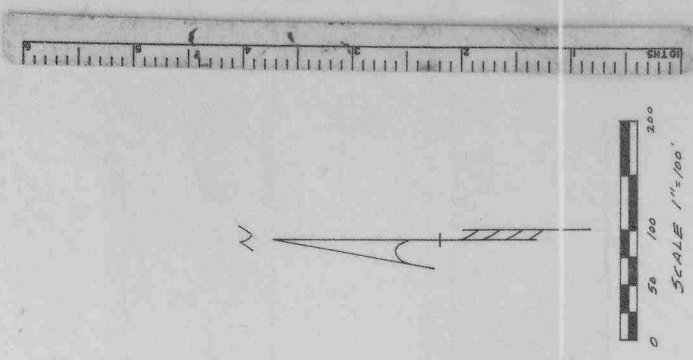
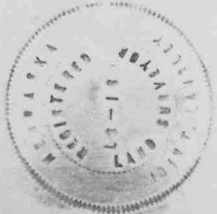
SURVEYOR'S CERTIFICATE

I, John T. Langley, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed HAVERICK ADDITION to Scotts Bluff County, Nebraska, a part of the South-west Quarter (SW¹/₄) North-east Quarter (NE¹/₄) Section Eleven (11) Township Twenty-five (25) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows:

Beginning at the southwest corner of said SW¹/₄ NE¹/₄; thence north along the West line of said SW¹/₄ NE¹/₄ for a distance of 647.6 feet; thence S 89°-41' E on a line parallel with the South line of said SW¹/₄ NE¹/₄ for a distance of 1344.6 feet more or less, to the east line of said SW¹/₄ NE¹/₄; thence S 0°-06' E along the said East line SW¹/₄ NE¹/₄ for a distance of 647.6 feet to the South line of said SW¹/₄ NE¹/₄; thence N 89°-41' W along the said South line SW¹/₄ NE¹/₄ for a distance of 1345.8 feet more or less to the point of beginning. EXCEPTING a tract of unplatted land described as follows: Beginning at a point 3 1/2 feet East of the SW Corner of said SW¹/₄ NE¹/₄; thence north and parallel to the West line of said NE¹/₄ a distance of 607.52 feet; thence S 0°-06' E a distance of 584.6 feet; thence N 89°-41' W a distance of 605.36 feet to the point of beginning and containing 8.11 Acres, and that the above plat is a true delineation of said survey drawn to a scale of 100 feet to the inch. All corners are marked as shown and all dimensions are in feet and decimals.
