5URVEYOR'S CERTIFICATE *

STATE OF NEBRASKA SCOTTS BLUFF COUNTY)

This is to certify that I have surveyed a tract of land situated in the Southeast Quarter (SE'/4) of Section 24, Township 22 North, Range 55 West of the 6th P.M., in Scotts Bluff County, Nebraska. more particularly described as follows:

Beginning at the Northwest Corner of Lot Z, Block I, East Portal Addition to the City of Scottsbluff, Scotts Bluff County, Nebraska; thence South 353 feet on the West Line of Lot 2, to the Southwest Corner of such Lot 2; thence West 200 feet on the North Line of Lots 4 and 5, Wildy and Land Industrial Tracts to the Northwest Corner of such Lot 5; thence South 245 feet to the North Line of 15th Street; thence West 270 feet on the North Line of 15th Street; thence North 225 feet parallel to the West Line of Lot 5, Wildy and Lana Industrial Tracts; thence West 30 feet parallel to 15th Street; thence North 413 feet parallel to the West Line of Lot 2, Block 1, East Portal Addition; thence East 155 feet to the Southwest Corner of Lot 1, Block 4, East Portal Addition; thence South 60 feet on the West Line of such Lot 1, extended South to the South Line of 17th Street; thence East 345 feet on the South Line of 17th Street to the point of beginning, containing 5.9 acres more or less.

That the accompanying Plat is a correct delineation of such survey drawn to a scale of 100 feet to an inch. That all dimensions are shown in feet and decimals. That all Block corners are marked with 5/8" × 36" iron rods and all other corners are marked with 5/8" × 18" iron rods. That the boundary of this sub-division is marked on the plat with a heavy datted line.
