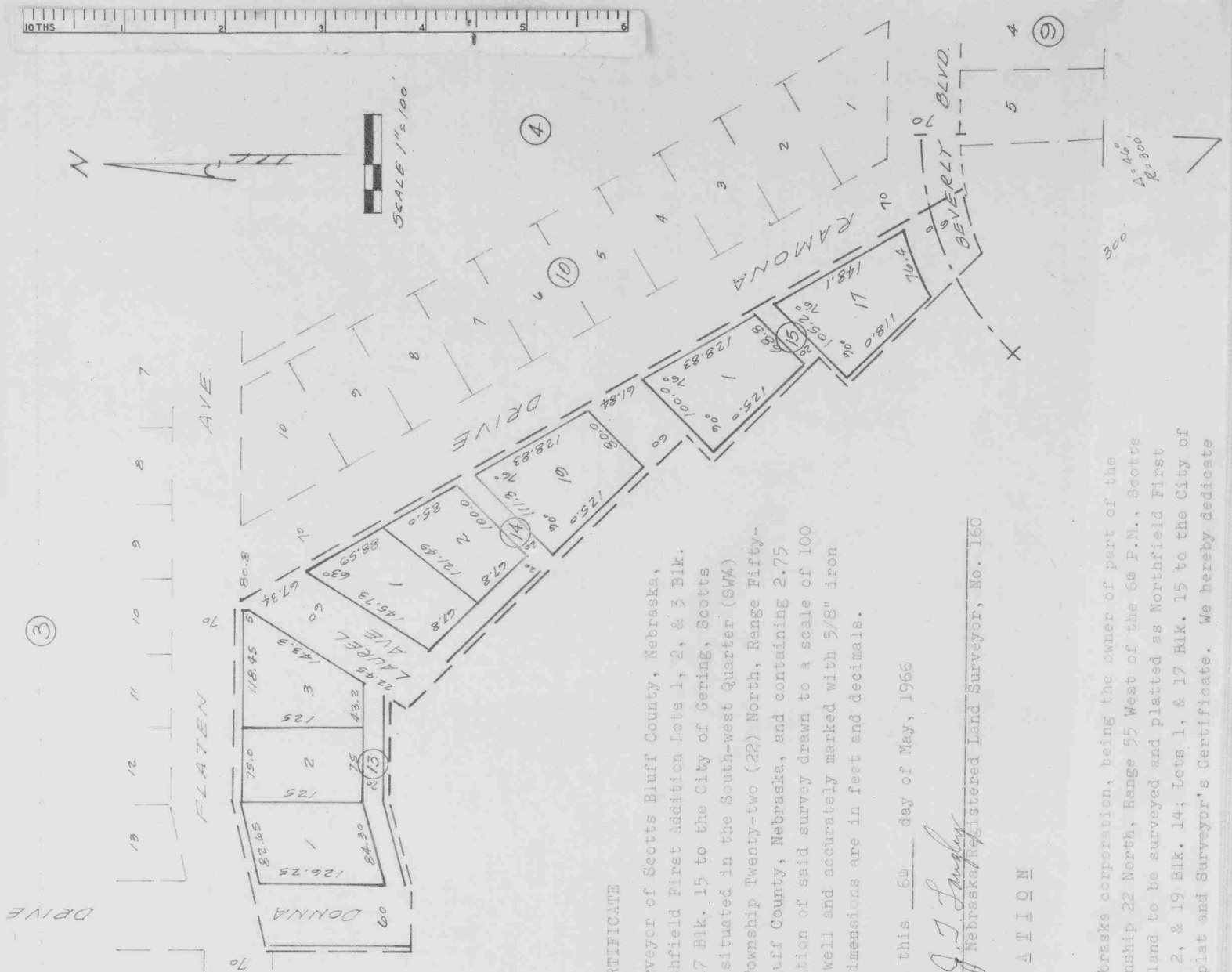

SURVEYOR'S CERTIFICATE

I, John T. Langley, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed Northfield First Addition Lots 1, 2, & 3 Blk. 13; Lots 1, 2, & 19 Blk. 14; Lots 1, & 17 Blk. 15 to the City of Gering, Scotts Bluff County, Nebraska, a tract of land situated in the South-west Quarter (SW^{1/4}) and the (NW^{1/4}) Section Thirty-five (35) Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M.; Scotts Bluff County, Nebraska, and containing 2.75 Acres.
