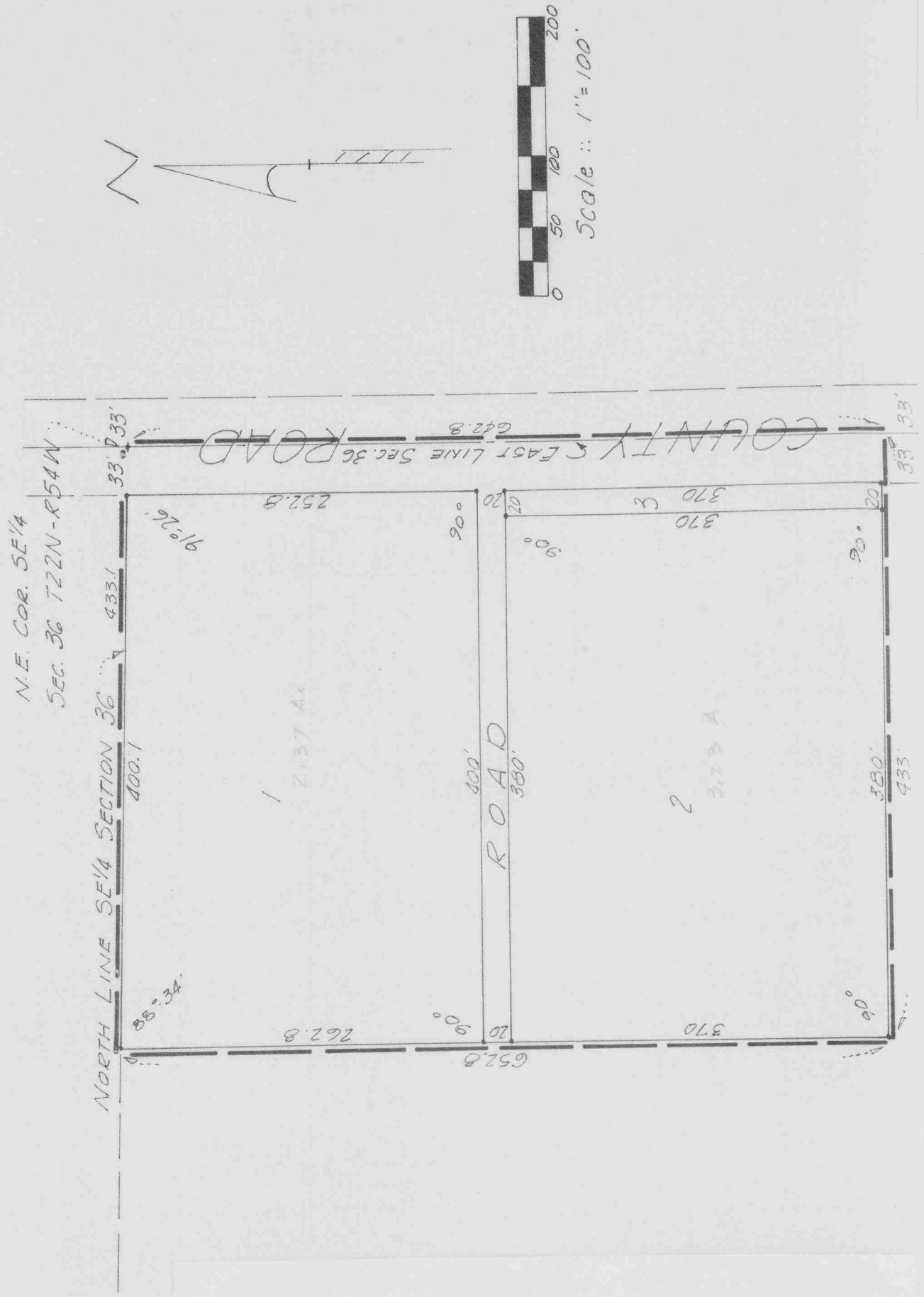

SURVEYOR'S CERTIFICATE

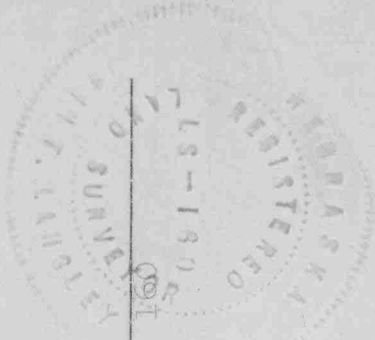
I, John T. Langley, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed Lots 1, 2 and 3, AULICK'S SUBDIVISION situated in the Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section Thirty-six (36), Township Twenty-two (22) North, Range Fifty-four (54) West of the 6th P.M., Scotts Bluff County, Nebraska, and more particularly described as follows: Beginning at the Northeast corner of said SE $\frac{1}{4}$  of Section 36; thence South on the East line of said SE $\frac{1}{4}$  a distance of 642.8 feet; thence angle right 90°-00' a distance of 433 feet; thence angle right 90°-00' a distance of 652.8 feet; thence angle right 91°-26' a distance of 433.1 feet to the point of beginning and containing 6.44 Acres. The above plat is a true delineation of said survey drawn to a scale of 100 feet to the inch. That all corners are well and accurately marked with 5/8" iron rods driven well into the ground. All dimensions are in feet and decimals.
