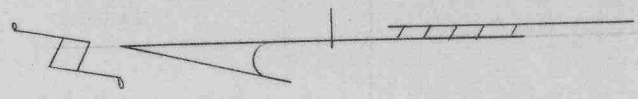
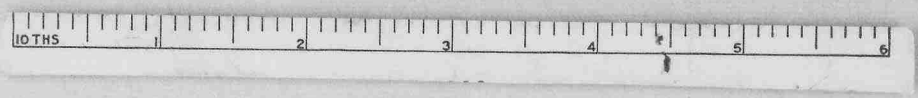
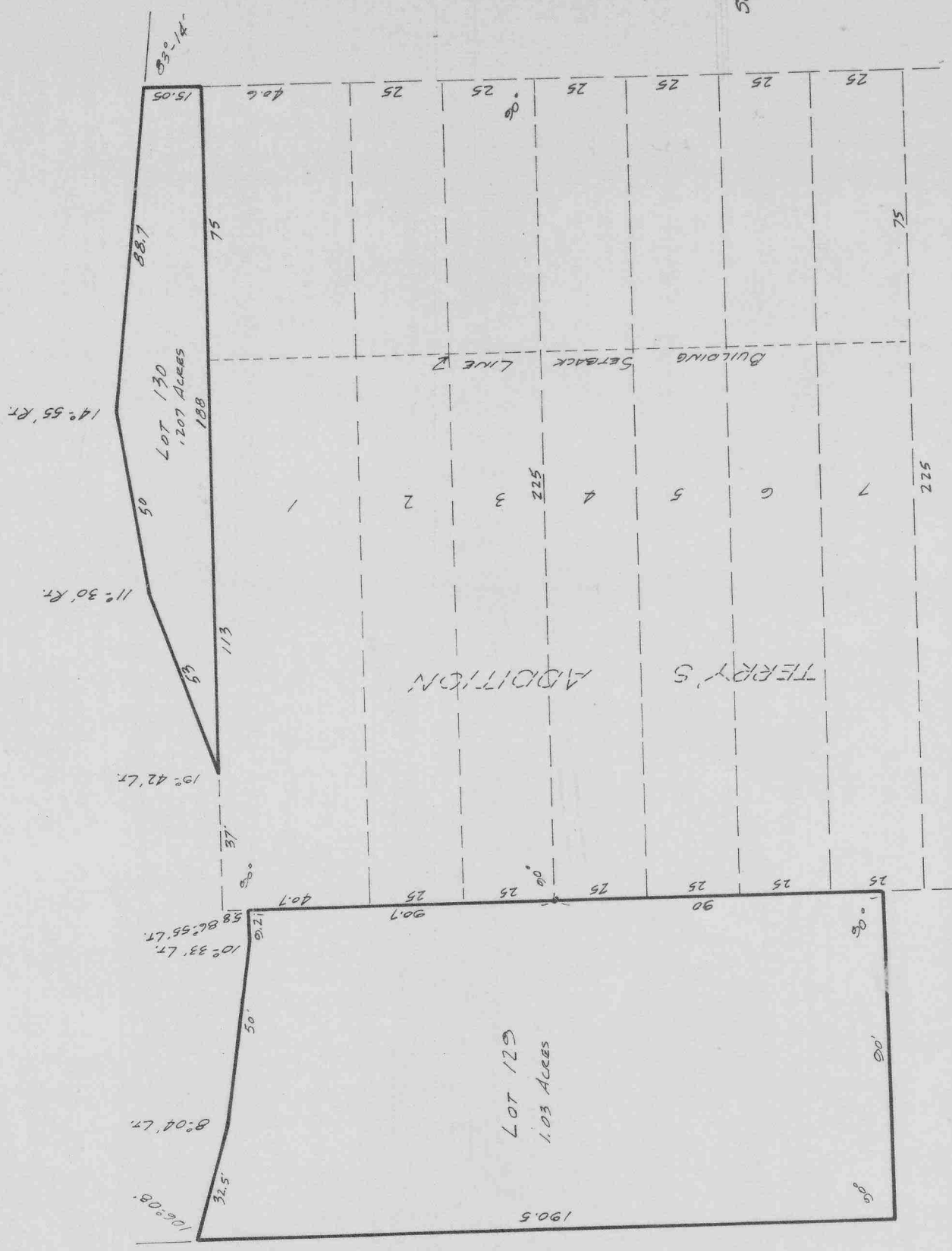


LOTS 129 & 130 VILLAGE OF TERRYTOWN

Langley, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed Lots 129 and 130, Village of Terrytown, Scotts Bluff County, Nebraska, situated on a part of the South-east Quarter (SE $\frac{1}{4}$) of Section Twenty-six (26), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6 $\frac{1}{2}$ P.M., more particularly described as follows: LOT 129 - Beginning at the South-west Corner of Lot 3, Terry's Addition to Scotts Bluff County as platted and recorded in the Register of Deeds Office, Scotts Bluff County Courthouse, Gering, Nebraska; thence south along the West Line of said Terry's Addition a distance of 90 feet; thence right 90°-00', a distance of 90 feet; thence right 90°-00', a distance of 190.5 feet; thence right 106°-08' a distance of 32.5 feet; thence left 8°-04' a distance of 50 feet; thence left 10°-33' a distance of 9.2 feet to a point on the West Line of said Terry's Addition and 5.8 feet south of the North-west Corner of Lot One, said Terry's Addition; thence south along the West Line of said Terry's Addition a distance of 90.7 feet to the point of beginning; containing 1.03 Acres. LOT 130 - Beginning at the North-east Corner of Lot One of said Terry's Addition; thence west on the North Line of said Lot 1 a distance of 188 feet; thence right 160°-18' a distance of 53 feet; thence right 11°-30' a distance of 50 feet; thence right 14°-55' a distance of 88.7 feet; thence right 83°-14' a distance of 15.05 feet to the point of beginning. Containing .207 Acres. That the accompanying plat is a true delineation of said survey drawn to a scale of 30 feet to one inch. All corners are marked with 5/8" x 18" iron rods. All dimensions are in feet and decimals. That the boundaries of Lots 129 and 130 are shown by heavy solid lines.

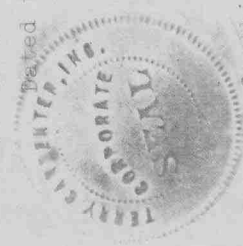
