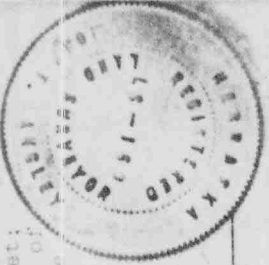
SURVEYOR'S CERTIFICATE

I, John F. Langley, a competent surveyor of Scott's Bluff County, Nebraska, hereby certify that I have surveyed BLOCK 16, NORTHFIELD ADDITION TO THE CITY OF GERING, NEBRASKA, in part of West Half of the South-west Quarter (W/4 SW/4) of Section Thirty-five (35), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M., Scott's Bluff County, Nebraska, more particularly described as follows: Beginning at the Southeast Corner of said W/4 SW/4; thence west on the South Line of said W/4 SW/4 a distance of 298 feet; thence south 298 feet to the point of beginning, containing .77 Acres. That the above plat is a true dedication of said survey drawn to a scale of 100 feet to the inch. Iron pins are driven well into the ground at all corners. All dimensions are in feet and decimals.
