
NORTHEAST ADDITION

SURVEYOR'S CERTIFICATE

I, E.Y. Grupe, a competent surveyor of Scotts Bluff County, Nebraska do hereby certify that a survey has been completed under my direction comprising that part of the Northwest Quarter (NW/4) of Section Twenty-four (24), Township Twenty-Two (22) North Range Fifty-five (55) West of the Sixth Principal Meridian in Scotts Bluff County, Nebraska. That such land has been subdivided into Lots 11, 12, 13 \$ 14, Block 2, NORTHEAST ADDITION to the City of Scottsbluff, Nebraska as shown on the accompanying plat. The boundary of the land wherein

such subdivision is situated is more particularly described as follows;

Beginning at a point on the east line of 5th Avenue and on the Northwest corner o' Lot 10, Block 2, NORTHEAST ADDITION to the City of Scottsbluff, Nebrasko as previously platted and recorded; thence North on such eastline of 5TH Avenue, a distance of 370.4 feet to the South line of 24TH street; thence east and perpendicular to the east line of 5th Avenue, a distance of 152.25 feet on the south line of such 24th Street; thence south and parallel to the aforementioned east line of 5th Avenue a distance of 370.4 feet to a point 20 feet East of the Easterly extension of the Northeast corner of the aforementioned Lot 10, Block 2, NORTHEAST ADDITION; thence west 152.25 feet to the point of beginning, containing 1.75 acres more or less.

That the accompanying plat is a correct delineation of such survey drawn to a scale of 100 feet to one inch with all dimensions shown thereon

in feet and decimals.

That the Block corners and boundaries of the Addition are marked with 5/8" x 36" Iron Rods. That all lot corners are marked with 5/8" Iron Rods.
