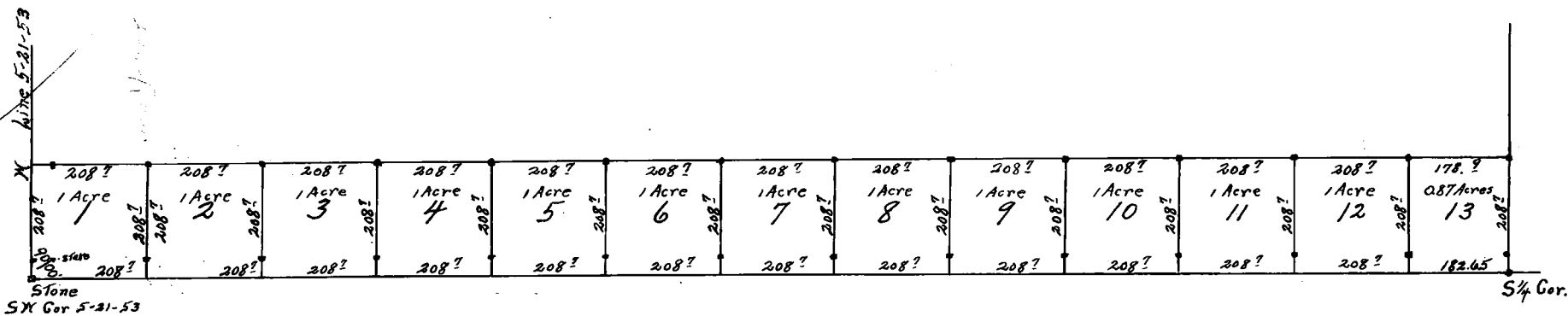

PLAT OF ACRE TRACTS IN SEC. 5 TWP 21 - R 53

I HEREBY CERTIFY that on the 14th day of October I surveyed a part of the S.W. Quarter of Sec 5 Twp 21 R 53 and sub-divided it into Acre Tracts, the part subdivided being described as follows: Beginning at the S. W. Corner of said sec 5, thence North on the West line of said sec 5, a distance of 208.7 _____, thence East on a line parallel with the South line of Sec 5, a distance of 2683.3 feet, thence South on the center line of sec. 5, a distance of 208.7 feet to the South Quarter corner of Sec 5, thence West a distance of 2687.05 feet to the point of beginning; That the above plat is a correct delineation of said survey drawn to a scale of 200 feet to an inch. 2"x2" Square stakes were driven well into the ground at the back corners of the tracts and 33 feet back of the front line of the tracts, so as to be on the fence line. Locations of stakes are shown on the plat by squares . . . The dimensions and numbers of the tracts are indicated on the plat. Each tract bears it's own number.
