

ADDITION to Scottsbluff, Nebraska, situated on a part of Sec 26, Twp 22 N of R 55 W of the 6th P.M., described as follows: Beginning at a point which is 1504 feet west and 33 feet south of the north Quarter corner of said Sec 26, thence East for a distance of 50 feet, thence south for a distance of 300 feet, thence East for a distance of 320 feet, thence South for a distance of 13 feet, thence East a distance of 60 feet, thence South a distance of 287 feet, thence West 430 feet, thence North a distance of 600 feet to the point of beginning; that the above plat is a correct delineation of said survey drawn to a scale of 200 feet to the inch. 2"x2"x14" Fir stakes are driven well into the ground at front corners of each lot.
