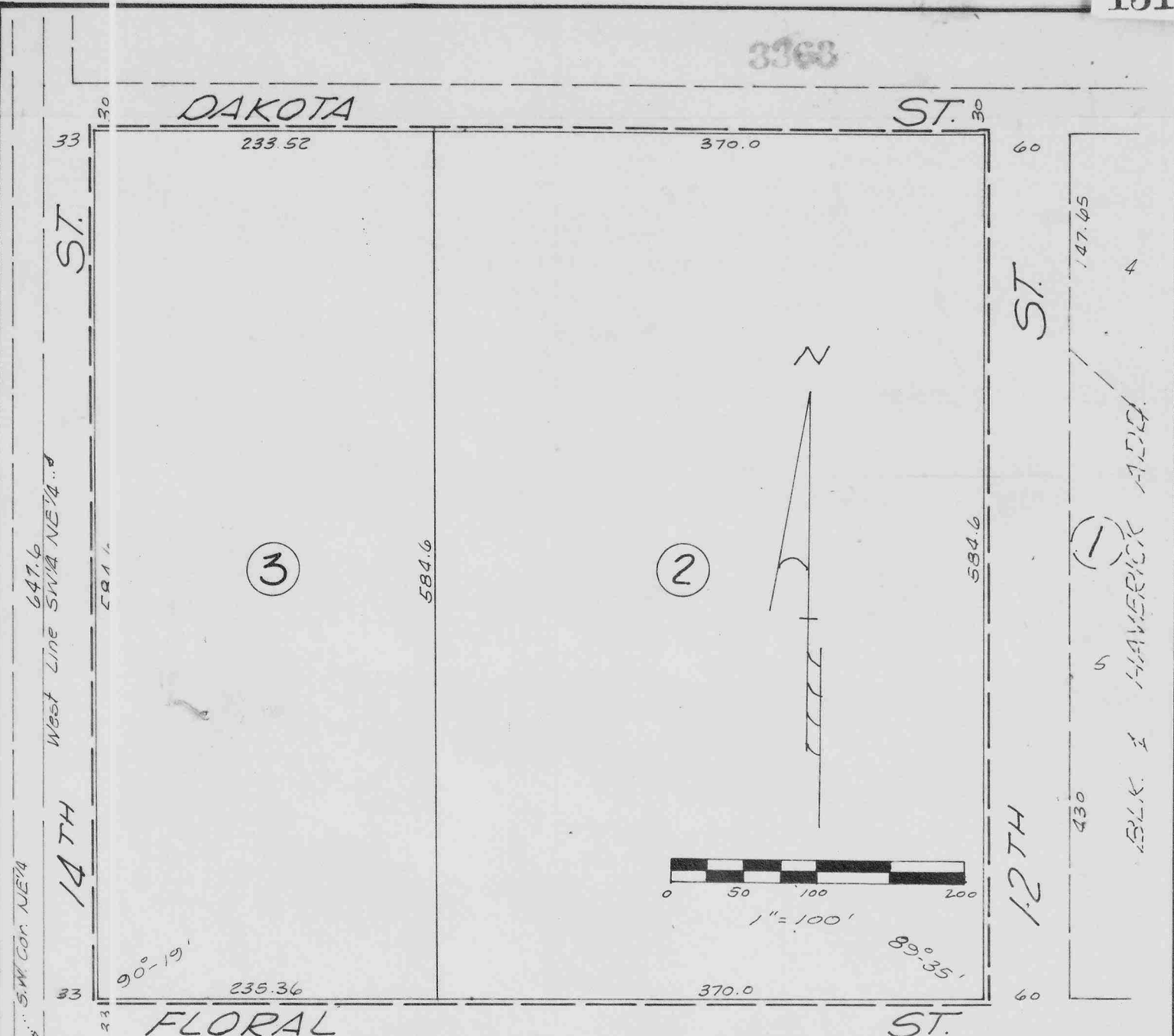

SURVEYOR'S CERTIFICATE

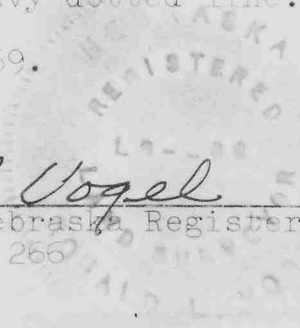
I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska hereby certify that I have surveyed BLOCK TWO AND BLOCK THREE, Haverick Addition to Scotts Bluff County, Nebraska, situated on a part of the South west Quarter of the Northeast Quarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$) of Section Eleven (11), Township 21 North Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, the boundary of such subdivision being more particularly described as follows:

Beginning at a point that is 33 feet North and 33 feet East of the southwest corner of such SW $\frac{1}{4}$ NE $\frac{1}{4}$, such point also being the intersection of the North Line of Floral Street and the East Line of 14th Street; thence north on the East Line of 14th Street a distance of 584.6 feet to the South Line of Dakota Street; thence east on the South Line of Dakota Street a distance of 603.52 feet to the West Line of 12th Street; thence south of the West Line of 12th Street a distance of 584.6 feet to the North Line of Floral Street; thence west on the North Line of Floral Street a distance of 605.36 feet to the point of beginning, containing an area of 8.11 acres, more or less of deeded land.

That the accompanying Plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all dimensions are in feet and decimals. That each Block bears its own number. That 5/8"x18" iron rods are driven well into the ground at all corners. That the boundary of the subdivision is shown on the plat with a heavy dotted line.
