
NORTHFIELD FIRST ADDITION LOTS 6 THRU 16, BLOCK 18 TO THE CITY OF GERING, NEBRASKA

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed Lots Six through Sixteen, Block Eighteen, Northfield First Addition to the City of Gering, Scotts Bluff County, Nebraska, situated on a part of the Northeast Quarter of the Southwest Quarter of Section Thirty-five, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows:

Beginning at the Southwest corner of Lot 17, Block 18, Northfield First Addition to the City of Gering as surveyed and platted; thence West on the North Line of Gentry Boulevard a distance of 326.4 feet to the East Line of the southwestern part of Block 17, Northfield First Addition, as platted; thence North and Northeasterly along the East and South Lines of such Block 17 to a point which is on the Northerly extension of the West Line of Lot 5, Northfield First Addition, as platted; thence south on such extension and the West Line of such Lot 5 a distance of 170.0 feet to the North Line of the alley platted in such Block 18; thence West on the North Line of such alley a distance of 101.4 feet; thence deflect left 23 degrees 39 minutes along the North Line of such alley a distance of 288.25 feet; thence deflect left 97 degrees 23 minutes a distance of 20.0 feet to the Northwest corner of Lot 18 of such Block 18; thence south on the West Lines of such Lots 17 and 18, Block 18, a distance of 135.4 feet to the point of beginning; containing an area of 4.3 acres, more or less, of deeded land.

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch.

That all corners are marked with 5/8" diameter iron rods.

That all dimensions are in feet and decimals.

That each Lot and Block bears its own number.

That the boundary of the subdivision is shown on the plat with a heavy dotted line.
