

SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed BELLEVUE HOMES SECOND ADDITION, Lots I through 5, a subdivision of part of the Southeast Quarter (SE\(\frac{1}{4}\)) of Section Twenty-Seven (27), Township Twenty-Two (22) North, Range Fifty-Five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, the boundary of such subdivision being more particularly described as follows:

Beginning at the Northwest corner of Lot 31, Bellevue Homes Addition, thence Northwesterly, on the extension of the North line of such Lot 31, a distance of 102.80 feet; thence a deflection angle left of 30 degrees 50 minutes a distance of 369.20 feet; thence a deflection angle left of 109 degrees 46 minutes a distance of 200.1 feet; thence a deflection angle left of 90 degrees 00 minutes a distance of 45.67 feet; thence a deflection angle right of 18 degrees 00 minutes a distance of 157.43 feet; thence a deflection angle right of 34 degrees 30 minutes a distance of 103.20 feet to a point, such point being on the Southerly extension of the West line of the aforesaid Lot 31; thence Northerly on such extension and the West line of such Lot 31 a distance of 197.20 feet to the point of beginning, containing an area of 7.55 acres, more or less.

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch.

That each Lot bears its own number.


That all corners are marked with 5/8" x 18" iron rods.
