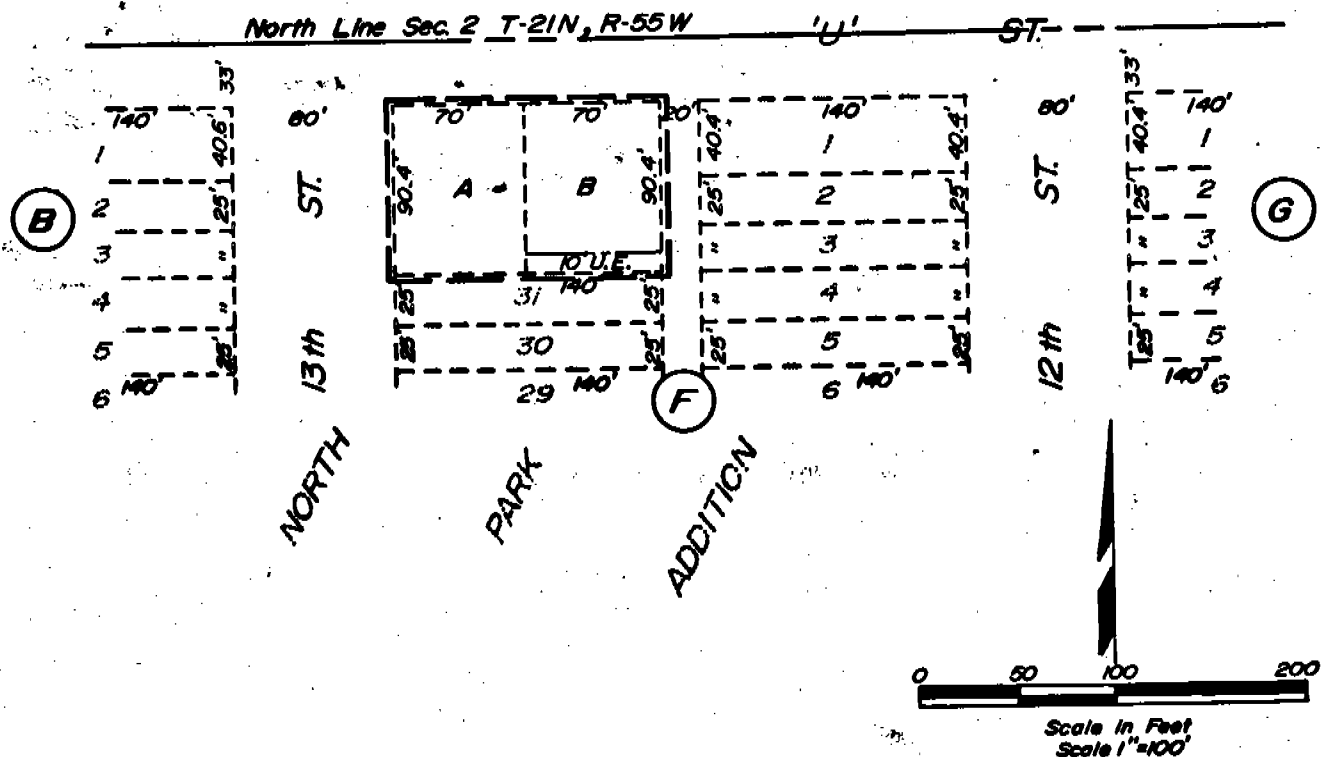

in the NE 1/4, Section 2, T-21 N., R-55 W.

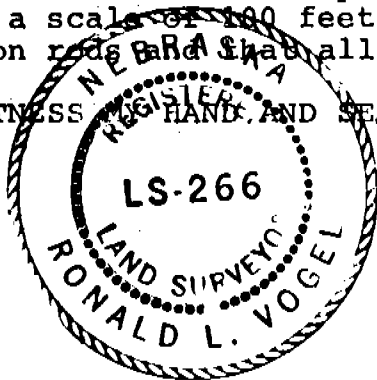


SURVEYOR'S CERTIFICATE
