SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and platted COTTONWOOD GLEN, LOTS ONE THROUGH FOUR, BLOCK ONE, LOTS ONE, THROUGH FIFTLEN, BLOCK TWO, a subdivision of part of the Southeast Quarter (SE_4), of Section Seventeen (17) Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P. H., Scotts Bluff County, Nebraska the boundary of such subdivision being more particularly described as follows

Reginning at the Northeast corner of such SEL; then South on the East Line of such SEX; a distance of 861.00 feet to the North Right of Way Line of the Winter Creek Canal; then a deflection angle to the right of 99 degrees 14 minutes 22 seconds, on such Right of Way Line, a distance of 224.30 feet; then a deflection angle to. the left of 14 degrees 11 minutes 45 seconds a distance of 330.00 feet, then a deflection angle to the left of 02 degrees 54 minutes 54 seconds a distance of 510.00 feet; then a deflection angle to the right of 18 degrees 12 minutes 12 seconds; and distance of 215.00 feet; then a deflection angle to the right of 79 degrees 45 and nutes 47 seconds a distance of 620.00 feet; then a deflection angle to the right of 89 degrees 32 minutes 17 seconds, a distance of 190.00 feet; then a deflection angle to the left of 89 degrees 42 minutes 42 seconds a distance of 256.30 feet to the North Line of the SEz; then a deflection angle to the right of 89 degrees 30 minutes 42 seconds, on the North Line of such SEt, a distance of 1075.30 feet to the point of beginning, such tract of land containing an area of 24.04 acres, more or less.

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all dimensions are in feet and decimals and that all corners are marked with 3/4" x 18" iron rods. That each lot bears its own number and that the boundary of the subdivision is shown on the plat with a heavy solid line.
