

SURVEYOR'S CERTIFICATE

I, M. C. Schaff, a competent Surveyor of Scotts Bluff County, Nebraska, do hereby certify that I have surveyed a tract of land formerly known as Lot Twenty (20) and the alley between Lot Nineteen (19) and Lot Twenty (20), Park View Tracts and an Addition to the City of Scottsbluff, Nebraska, situated in the Northwest Quarter of the Northeast Quarter (NW4NE4) of Section Twenty-Seven (27), Township Twenty-Two (22) North, Range Fifty-Five West of the Sixth (6th) Principal Meridian (P.M.) in Scotts Bluff County, Nebraska, more particularly described as follows:

Commencing at the Northeast corner of said Section Twenty-Seven (27); then, West on the North Line of said Section Twenty-Seven (27), a distance of 1,653.30 feet; then, a deflection angle to the left of 90 degrees 00 minutes, a distance of 33 feet, to the point of beginning; then, continuing along the last described course, a distance of 147.5 feet; then, a deflection angle to the right of 90 degrees 00 minutes, a distance of 97.22 feet; then, a deflection angle to the right of 90 degrees then, a deflection angle to the right of 90 degrees 00 minutes, a distance of 97.22 feet, to the point of beginning, an area containing 0.33 acres, more or less.
