SURVEYOR' S CERTIFICATE

I, M. C. Schaff, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and subdivided Block One (1), Northeast Second Addition according to the recorded plat thereof and have prepared a plat of such land and designated the same as Subdivision of Block One, Northeast Second Addition, Replat No. 1.

That such Block One has been surveyed and subdivided as Lots One, Two, and Three, Block One, with a portion of such Block One being dedicated as part of a Frontage Road, Northeast Second Addition, Replat No. 1, an addition to the City of Scottsbluff Nebraska.
