

1827 MARVIN ADDITION

A SUBDIVISION OF PART OF GOV. LOT I IN THE NWI/4 OF SEC. 26, T22N, R55W OF THE 6th P.M. IN THE CITY OF SCOTTSBLUFF NEBRASKA. (the West 300 of Tax Lot 36,40 and41A lying North of the South Beltline Highway)



SURVEYOR'S CERTIFICATE

I. Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Repraska hereby certify that I have surveyed a part of Government but One (1) in the NW. of Section Twenty-six (26), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska (also known as the West 300' of Tax Lot 36, 40 % 41A lying North of the Beltline Highway) the boundary of such tract being more particularly described as follows:

With reference to the Northwest corner of such Section 26; then East on the North Line of such Section 26 a distance of 346.50 feet to the point of beginning; then continuing East on the North Line of such Section a distance of 300.00 feet; then a deflection angle to the right of 89° 23′ 10″, along the West Line of a tract of land owned by the City of Scottsbluff, a distance of 1341.94 feet to the North Right of Way Line of the South Beltline Highway West; then a deflection angle to the right of 112° 07′ 50″, on such right of way line, a distance of 324.05 feet to the East Line of Block 1, County Addition, according to the recorded plat thereof; then a deflection angle to the right of 67° 52′ 10″ on the East Line of such County Addition and East Line of Graves Tracts, according to the recorded plat thereof, a distance of 1223.42 feet to the point of beginning, containing an area of 8.83 acres, more or less.

That I have further surveyed and subdivided such land as above described as "Marvin Addition" Lots 1 through 10, Block 1, Lots 1 through 8, Block 2 and Block 3, and including part of West Overland Drive, Avenue H and 11th Street.

That the accompanying plat is a true delineation of such survey and subdivision drawn to a scale of 100 feet to the inch. That all Block corners are marked with 3/4 " x 36" iron rods and other corners with 3/4" x 18" iron rods. That all dimensions are in feet and decimals and that each Lot and Block bears its own number. That the boundary of the subdivision is shown with a heavy solid line and adjoining areas are shown in dashed lines for orientation purposes.
