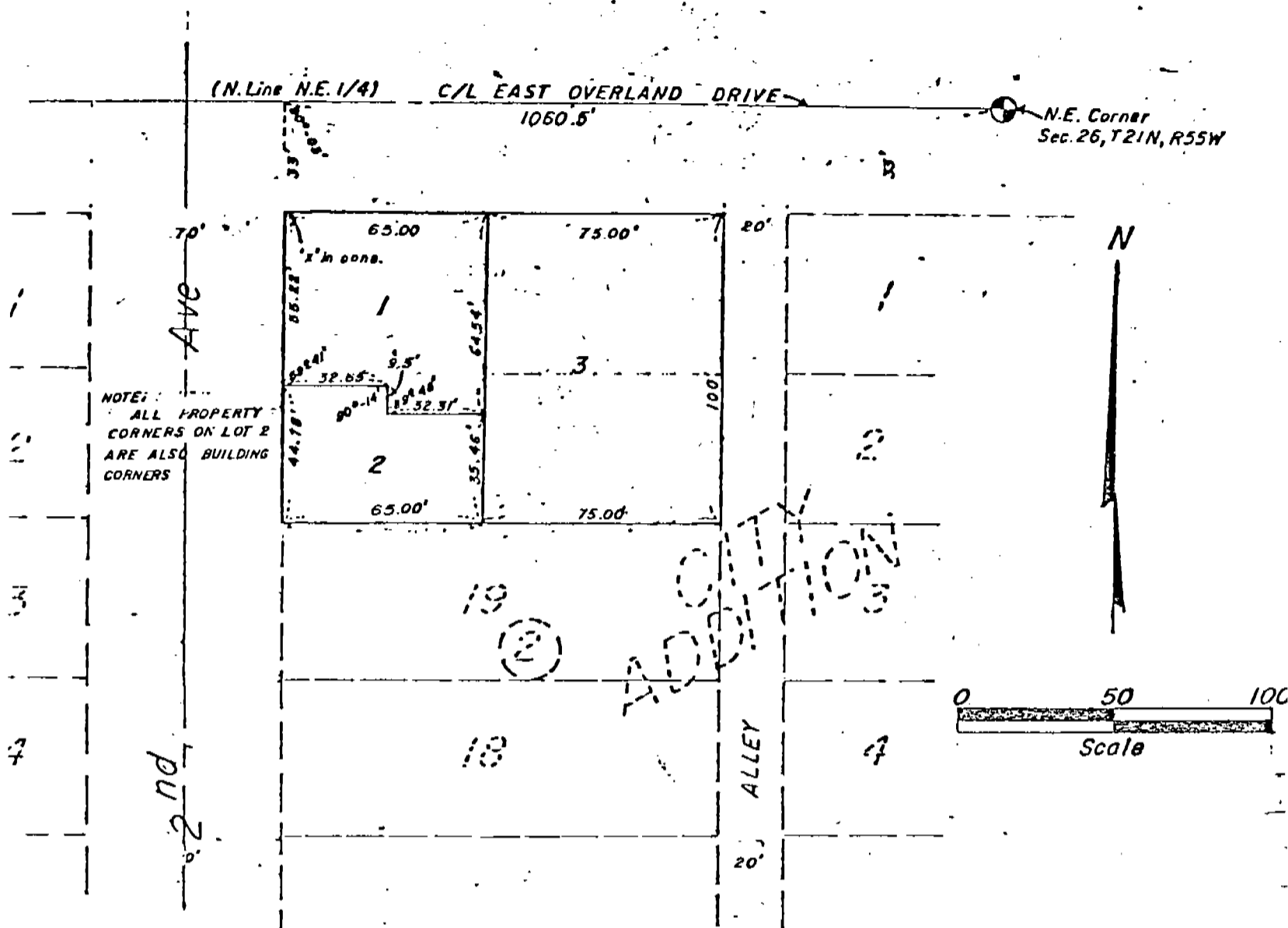

IN THE CITY OF SCOTTBLUFF, NEBRASKA.



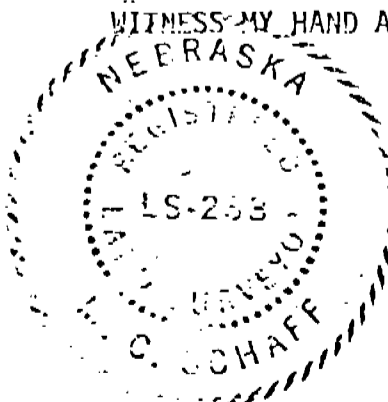
SURVEYOR'S CERTIFICATE

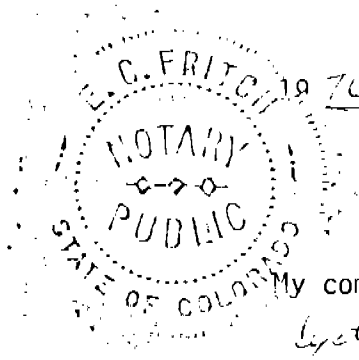

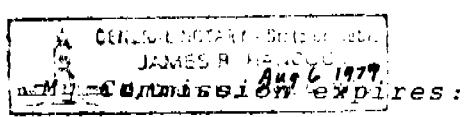

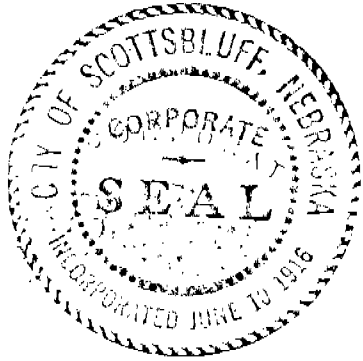
