### SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed a part of the Northwest Quarter (NW $_4^1$ ) of Section Twelve (12), Township Twenty-one (21) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, being more particularly described as follows:

Beginning at the Northwest corner of such Section 12; then North 89 degrees-44 minutes-40 seconds East on the North Line of such Section 12, a distance of 443.0 feet to the point of beginning; then continuing North 89 degrees-44 minutes-40 seconds East on the North Line of such Section 12, a distance of 1870.0 feet; then South 00 degrees-00 minutes-00 seconds Bast, a distance of 933.0 feet; then South 89 degrees-44 minutes-40 seconds West, parallel to the North Line of such Section 12, a distance of 1870.0 feet; then North 00 degrees-00 minutes-00 seconds East, a distance of 933.0 feet to the point of beginning, containing an area of 40.05 acres, more or less.
