SURVEYOR'S CERTIFICATE

I, M. C. Schaff, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed Indian Hills Addition to the City of Scottsbluff, Nebraska, Lot 22, Block 2, Lots 1 through 4, Block 10, Lots 1 through 5, Block 11, Lots 1 through 4, Block 12 and those portions of 17th Avenue, 18th Avenue, 30th Street and 32nd Street lying adajent to said Lots and Blocks and that the South 170.0 feet of aforementioned Lot 1, Block 12 is a replat of previously platted and henceforth to be vacated, Lots 1 through 4, Block 12, Indian Hills Addition to the City of Scottsbluff, Nebraska, and that such survey subdivision, and replat is situated within the East Half (E½) of the Southeast Quarter (SE¾) of Section 13, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, and is more particularly described as follows;

Commencing of the Southwest Corner of the East Half of the Southeast Quarter of Section 13; thence North, along the West Line of the East Half of the Southeast Quarter, a distance of 736.13 feet to the point of Beginning; thence continuing along the last described course, a distance of 1066.85 feet to the Centerline of the Enterprise Irrigation District Canal; thence a deflection angle right of 95 degrees, 34 minutes, 30 seconds along such Centerline a distance of 136.88 feet; thence a deflection angle left of 04 degrees, 41 minutes, 52 seconds, along such Centerline a distance of 196.52 feet; thence a deflection angle left of 04 degrees, 42 minutes, 09 seconds, along such Centerline a distance of 68.29 feet; thence a deflection angle right of 93 degrees, 49 minutes, 31 seconds, a distance of 858.36 feet, to the Northeast Corner of Lot 19, Block 2, INDIAN HILLS; thence a deflection angle right of 89 degrees, 35 minutes along the North Line of such Lot 19 a distance of 95.0 feet to the West Line of such Block 19; thence a deflection angle left of 89 degrees, 35 minutes, a distance of 193.9 feet to the casterly extention of the North Right of Way of 29th Street as previously recorded; thence a deflection angle right of 89 degrees, 35 minutes, along the North Right of Way of 29th Street, a distance of 305.0 feet to the point of beginning; containing an area of 9.24 acres, more or less.

That the accompanying plat is a true delineation of such survey and subdivision drawn to a scale of 100 feet to the inch. That all Block corners are marked with 3/4" x 36" iron rods and that all Lot corners are marked with 3/4" by 18" iron rods and that all dimensions are in feet and decimals. That each Lot and Block bears its own number and that boundary of the Subdivision is shown on the Plat with a heavy solid line.
