

SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed Gallawa Subdivision, Lots 1, 2 and 3, a part of the Northeast Quarter of Section Seventeen (17), Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska.

The boundary of the subdivision is more particularly described as follows:

With reference to the Northeast corner of such NE¼; then, South on the East Line of such NE¼, a distance of 1010.9 feet to the point of beginning; then, continuing South on the East Line of such NE¼, a distance of 325.6 feet; then, a deflection angle to the right of 90 degrees 10 minutes, a distance of 370.35 feet; then, a deflection angle to the right of 89 degrees 50 minutes, a distance of 175.6 feet; then, a deflection angle to the right of 90 degrees 10 minutes,

a distance of 100.0 feet; then, a deflection angle to the left of 90 degrees 10 minutes, a distance of 150.0 feet; then, a deflection angle to the right of 90 degrees 10 minutes, a distance of 270.35 feet to the point of beginning, containing an area of 2.43 acres. *The foregoing description of Gallawa Subdivision does not conform to the legal description of the property as described in the deed. In making the survey of the subdivision, it was found that the property as situated on the ground was not in agreement with the deed. The description is accurate as for dimensions but the error was discovered in the directions of the lines.

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all corners are marked with iron rods and that all dimensions are
