

SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed a tract of land situated in the Northeast φ_{carter} of the Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section Thirty-five (35), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M., Rootts Bluff County, Nebraska, such tract being more particularly described as follows:

With reference to the Southwest corner of such NEINEI; then East, on the bouth Line of such $NE_4^1NE_4^1$, a distance of 40.0 feet; then North 00 degrees-03 minutes-00 seconds East, parallel to the West Line of such NE4NE4, a distance of 35.0 feet to the point of beginning; then South 89 degrees-53 minutes-20 seconds East, a distance of 484.85 feet to the Southwest corner of Lot One (1), Scholl Subdivision to the City of Gering, Nebraska, according to the recorded plat thereof; then North 00 degrees-02 minutes-45 seconds West, on the West Line of such Lot 1, a distance of 445.25 feet to the North Right-ofway Line of the Central Irrigation District Canal; then South 74 degrees-45 minutes-45 seconds East, on such Right-of-Way, a distance of 619.1 feet; then North 15 degrees-07 minutes-30 seconds East, a distance of 162.2 feet; then North 62 degrees-42 minutes-50 seconds East, a distance of 93.4 feet; then South 72 degrees-12 minutes-10 seconds East, a distance of 78.3 feet to the East Line of such NE4NE4; then North 00 degrees-00 minutes-00 seconds on the Last bine of such NEINEI, a distance of 599.85 feet; then South 85 degrees-48 minutes-20 seconds West, a distance of 288.45 feet; then North 04 degrees-11 minutes-40 seconds West, a distance of 31.63 feet; then North 89 degrees-57 minutes-00 seconds West, a distance of 791.65 feet; then South 00 degrees-3 minutes-00 seconds West, a distance of 25.0 feet; then North 89 degrees-57 minutes-00 seconds West, a distance of 200.0 feet to a point on the East Sight-of-Way Line of Nebraska Highway No. N-71, such point being 40.0 feet Mast of the West Line of such NEANEA; then South 00 degrees-03 minutes-00 seconds west, a distance of 1,042.45 feet to the point of beginning, containing an area of 24.58 acres, more or less.

That I have further surveyed and subdivided such land as above described as MIDTOWN DEVELOPMENT, an Addition to the City of Gering, Nebraska. That the accompanying plat is a true delineation of such survey and subdivision, Brawn to a scale of 100 feet to the inch. That all corners are marked with 3/4" x 18" iron rods and that all dimensions are in feet and decimals. each lot and block bears its own number. That the boundary of the land subdivided is shown on the plat with a heavy solid line and that adjoining subdivided lands are shown dashed for orientation purposes.
