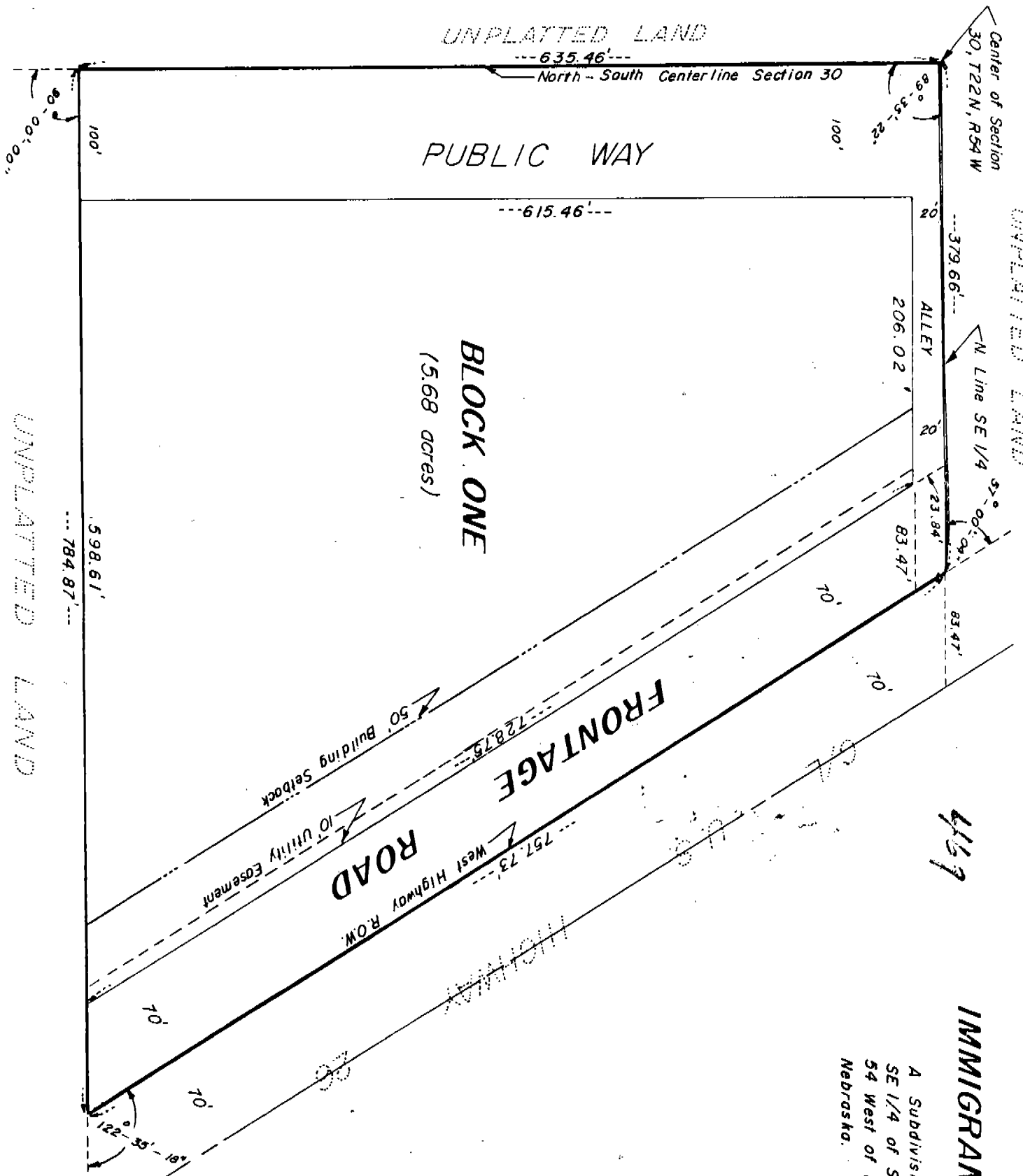


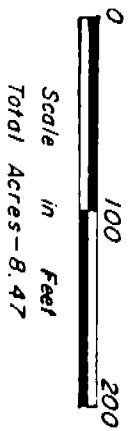
Map of Block One, Immigrant Trail Subdivision

SURVEYOR'S CERTIFICATE

I, M.C. Schaff, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and prepared a plat of part of the North Half of the Southeast Quarter (N $\frac{1}{2}$ SE $\frac{1}{4}$) of Section Thirty (30), Township Twenty-two (22) North, Range Fifty-four (54) West of the 6th P.M., Scotts Bluff County, Nebraska, the boundary of such survey being more particularly described as follows:

Beginning at a point on the Center of said Section 30; thence, South on the North-South Center Line of Section 30, a distance of 635.46 feet; thence, a deflection angle left of 90 degrees 00 minutes 00 seconds in an Easterly direction, a distance of 784.87 feet to a point on the West Right-of-Way Line of U.S. Highway No. 26; thence, a deflection angle left of 122 degrees 35 minutes 18 seconds in a Northwesterly direction on said Highway Right-of-Way Line, a distance of 757.73 feet to a point on the North Line of the Southeast Quarter of said Section 30; thence, a deflection angle left of 57 degrees 00 minutes 04 seconds on said North Line of the Southeast Quarter, a distance of 379.66 feet to the point of beginning, containing an area of 8.47 acres, more or less.

That the accompanying plat is a true delineation of such survey and plat drawn to a scale of 100 feet to the inch. That all Corners are set with 3/4" by 36" iron rods driven well into the ground. That all dimensions are in feet and decimals and that the boundary of the survey and plat is shown on the plat with a heavy solid line.

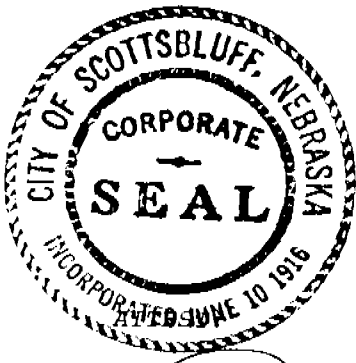
DEDICATION AND OWNER'S STATEMENT

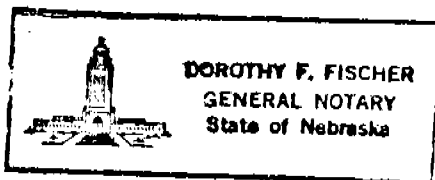

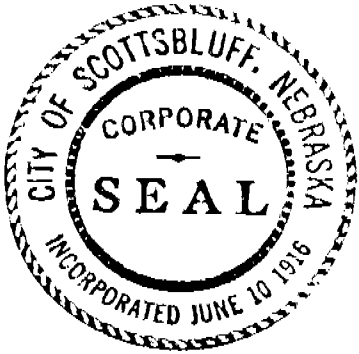
