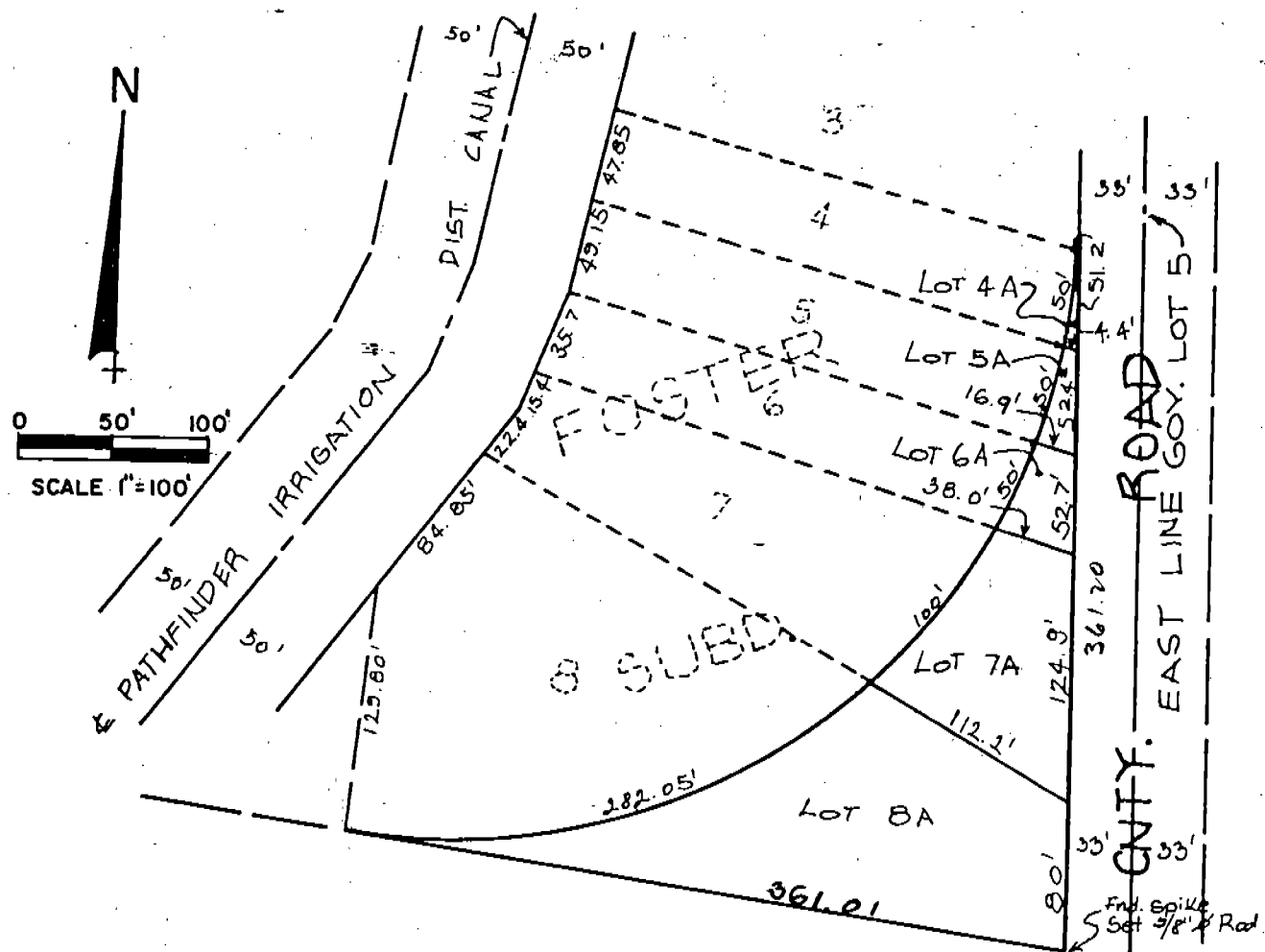

SURVEYOR'S CERTIFICATE

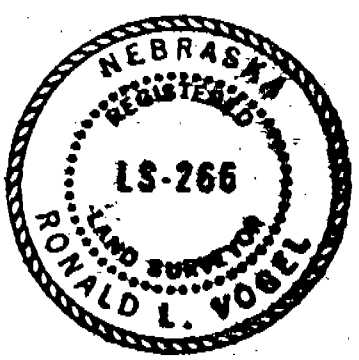
I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed a tract of land situated in part of Government Lot Five (5) in Section Twenty (20), Township Twenty-three (23) North, Range Fifty-three (53) West of the 6th P.M., Scotts Bluff County, Nebraska, such tract being more particularly described as follows:

Beginning at the Northeast corner of Lot 4, Foster Subdivision, a subdivision of part of Government Lot 5, according to the recorded plat thereof, such Northeast corner being 33.0 feet West of the East Line of such Government Lot 5; then South, parallel to the East Line of such Government Lot 5, a distance of 361.20 feet; then Northwesterly, a distance of 361.01 feet to the Southwest corner of Lot 8 of such Foster Subdivision; then Northeasterly on a curve being the East Line of Lots 8, 7, 6, 5 and 4, Foster Subdivision to the point of beginning.

That I have further surveyed and subdivided the land as above described as "Foster Subdivision, Lots 4A through 8A".

That the accompanying plat is a true delineation of such survey and subdivision, drawn to a scale of 100 feet to the inch. That all corners are marked with iron rods and that each lot bears its own number. That the boundary of the land subdivided is shown on the plat with a heavy solid line.

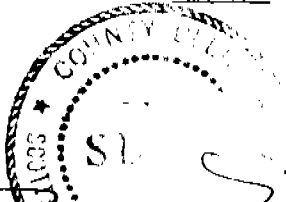
