
## SUBDIVISION OF LOTS 4454 3 & 4, BLOCK 12, INDIAN HILLS ADDITION

## SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and subdivided Lots 3 & 4, Block 12, Indian Hills Addition, in the City of Scottsbluff, Nebraska, and that said Subdivision will be known as SUBDIVISION OF LOTS 3 & 4, BLOCK 12, INDIAN HILLS ADDITION, more particularly described as follows:

Beginning at the Northwest corner of Lot 2, Block 12, Indian Hills Addition; thence, northerly on the East line of 17th Avenue, a distance of 398.9 feet to the Point of Curvature of a curve to the right, said curve having a radius of 20.00 feet and a central angle of 89 degrees 36 minutes 00 seconds; thence, northeasterly on the arc of said curve, a distance of 31.27 feet to the Point of Tangency of 'sald curve; thence, continuing easterly, tangent to said curve and on the South line of 32nd Street, a distance of 170.00 feet to the Point of Curvature of a curve to the right, said curve having a radius of 20.00 feet and a central angle of 90 degrees 25 minutes 00 seconds; thence, southeasterly on the arc of said curve, a distance of 31.56 feet to the Point of Tangency of said curve; thence, continuing southerly, tangent to said curve and on the West line of 18th Avenue, a distance of 398.9 feet to the Northeast corner of Lot 2, Block 12, Indian Hills Addition; thence, westerly on the North line of Lot 2, Block 12, Indian Hills Addition, a distance of 210.0 feet to the point of beginning, containing an area of 2.01 acres more or less.

That the accompanying plat is a true delineation of such Subdivision drawn to a scale of 100 feet to the inch. That the boundary of the Subdivision is shown with a heavy solid line and that the dashed lines are shown for orientation purposes. That each lot bears its own number and that all lot corners are marked with 3/4" x 18" iron bars driven well
