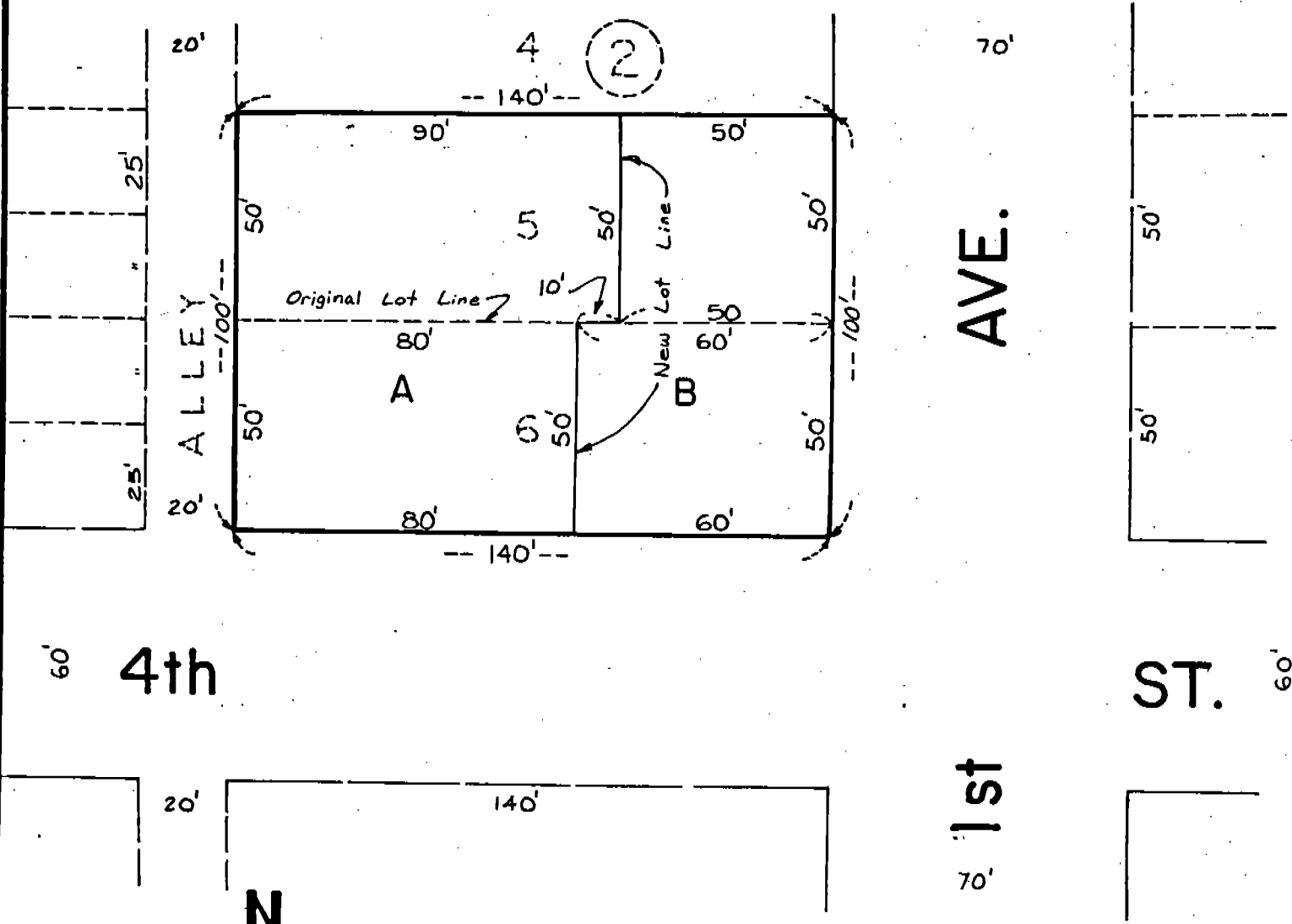

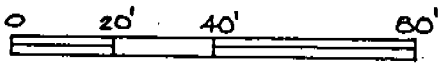

SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed Lots Five (5) and Six (6), Block Two (2), Original Town of East Minatare in the City of Minatare, Nebraska, according to the recorded plat thereof.

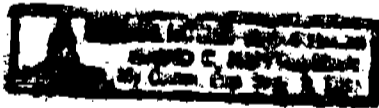
