# SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed a tract of land in the Southwest Quarter (SW 1/4) of Section One (1), Township Twenty-one (21) North, Range Fifty-five (55) West of the 6th P.M., being more particularly described as follows:

With reference to the Southwest corner of such Section 1; then North on the West Line of such SW 1/4, a distance of 1330.8 feet to the point of beginning; then continuing North on the West Line of such SW 1/4, a distance of 510.20 feet to a point on the South Line of "K" Street as platted; then a deflection angle to the right of 90°-00'-00" on the South Line of "K" Street, a distance of 413.02 feet to the East Line of 6th Street; then a deflection angle to the left of 89°-59'-05" on the East Line of 6th Street, a distance of 309.0 feet; then a deflection angle to the right of 89°-50'-45", a distance of 205.0 feet; then a deflection angle to the right of 90°-07'-30", a distance of 819.11 feet; then a deflection angle to the right of 89°-52'-30", a distance of 618.09 feet to the point of beginning, containing an area of 8.69 acres.

That I have further surveyed and subdivided such land as above described as "East Side Second Addition, Blocks One (1) and Two (2), including parts of streets therein, an Addition to the City of Gering, Nebraska"

That the accompanying plat is a true delineation of such survey and subdivision, drawn to a scale of 100 feet to the inch. That all corners are marked with 5/8" x 30" iron rods and that all dimensions are in feet and decimals. That each block bears its own number and that the boundary of the land subdivided is shown on the plat with a heavy solid line and that adjoining subdivided lands are shown dashed for orientation purposes.
