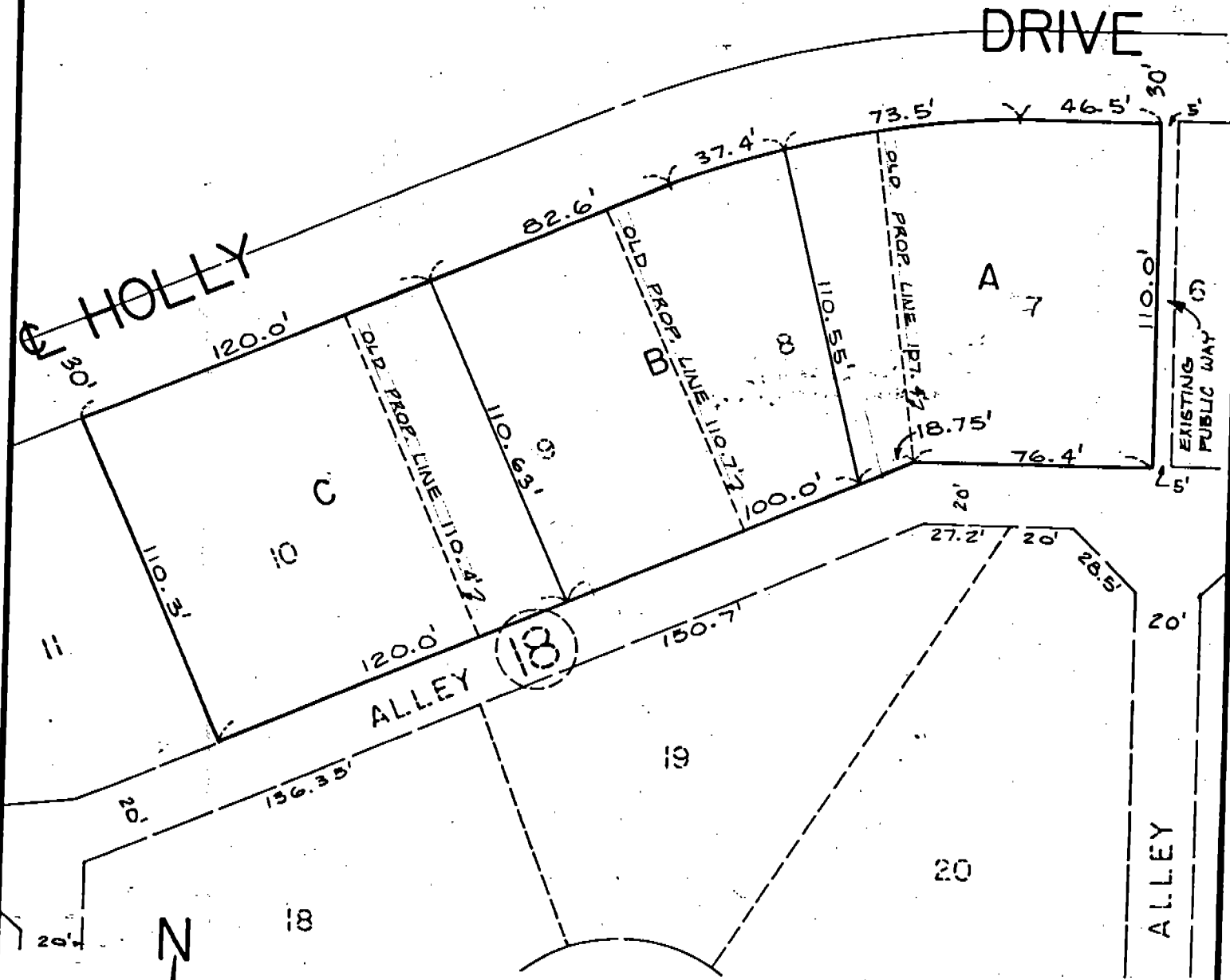

SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that a survey of Lots Seven (7) through Ten (10), inclusive, Block Eighteen (18), Northfield First Addition to the City of Gering, Nebraska, has been made under my direction. That I have prepared a replat of such former lots and designated the new lots as Lots A, B and C.

That the accompanying plat is a correct delineation of such survey, drawn to a scale of 50 feet to the inch, with all dimensions shown thereon in feet and decimals. That each new lot bears its own letter and that iron rods are driven well into the ground at all corners of the lots. That the boundary of the subdivision is shown on the plat with a heavy solid line and that adjoining lots are shown dashed for orientation purposes.
