

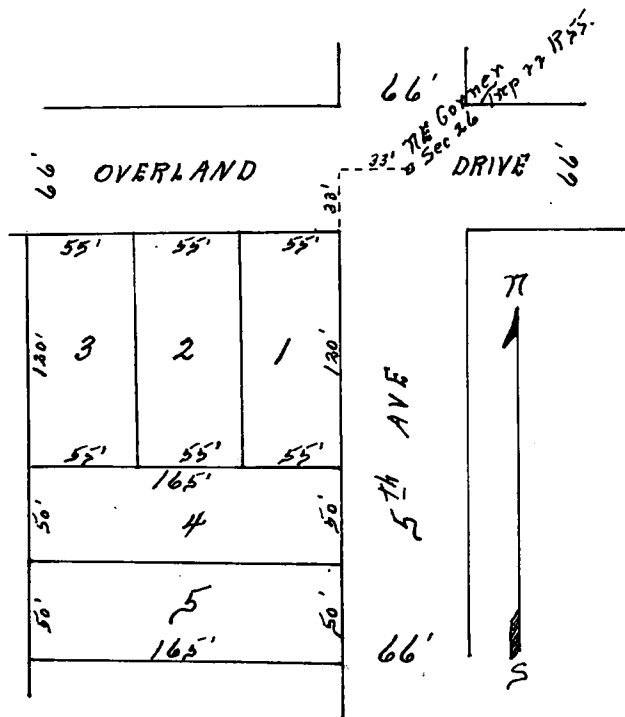

Scale 1"=100'. Selzer & Finley.

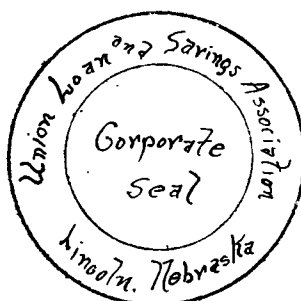


I HEREBY CERTIFY, THAT on the 6th day of May, A D 1924, I surveyed Hall Addition to Scottsbluff, Nebraska, situated on a part of the NE $\frac{1}{4}$ of Sec 26 Twp 22 N R 55 W of the 6th P.M., more fully described as follows: Beginning at a point which is 33 feet West and 33 feet South of the North East corner of the above described section 26; Thence South on a line parallel with the East line of said sec. 26, for a distance of 220 feet; Thence west on a line parallel with the North line of said sec 26 for a distance of 165 feet; Thence North on a line parallel with the East line of said sec 26 for a distance of 220 feet; Thence East for a distance of 165 feet to the point of beginning; That the above plat is a correct delineation of said survey drawn to a scale of 100 feet to the inch. One half inch pipes are driven well into the ground at the front corners of each lot. The dimensions of the lots are indicated on the plat in feet and decimals. Each lot bears its own number.
