SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed a tract of land situated in the Southwest Quarter (SW4) of Section One (1), Township Twenty-one (21) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, such tract being more particularly described as follows:

With reference to the Northwest corner of such SW% of such Section 1; then South 0 degrees-07 minutes-18 seconds West on the West Line of such SW4, a distance of 810.0 feet to a point on the Westerly extension of the South Line of "K" Street as platted; then South 89 degrees55 minutes-01 seconds East, on the South Line of "K" Street and its extension, a distance of 618.02 feet to the point of beginning, such point of beginning being on the East Line of Tax Lot 6; then North of degrees-09 minutes-37 seconds East, a distance of 60.0 feet; then MAST, parallel to the North Line of such SW4, a distance of 110.0 teet to the P.C. of a 30.0 foot radius curve to the left, whose Central Angle is 90 degrees-00 minutes; then along such curve to its point of termination, such point of termination also being the P.C. of a 125-foot radius curve to the right, whose Central Angle is 90 degrees-00 minutes; then along such curve to the right to its point of termination; then EAST, parallel to the North Line of such SW4, a distance of 400.0 feet; then South 00 degrees-07 minutes-18 seconds West, parallel to the West Line of such SW1, a distance of 545.0 feet; then WEST, parallel to the North Line of such SW%, a distance of 665.0 feet to a point on the East Line of Tax Lot 6B; then North 00 degrees-09 minutes-37 seconds East, a distance of 330.0 feet to the point of beginning, containing an area of 7.75 acres.

That I have further surveyed and subdivided the land as above described as "Pappas Second Addition to the City of Gering, Nebraska", Lots One (1) through Four (4), Block One (1); Lots One (1) through Three (3), Block Two (2); Lots One (1) through Six (6), Block Three (3); and Lots One (1) through Six (6), Block 4, including parts of streets and alleys therein.

That the accompanying plat is a true delineation of such survey and subdivision, drawn to a scale of 100 feet to the inch. That all corners are marked with 5/8" x 18" iron rods and that all dimensions are in feet and decimals. That each lot and block bears its own number and that the subdivision is drawn on the plat with solid lines and that adjoining lands are shown dashed for orientation purposes.
