SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and prepared a plat of a tract of land situated in the Southeast Quarter of Section 30 and the Northeast Quarter of Section 31, Township 22 North, Range 54 West of the 6th P.M., Scotts Bluff County, Nebraska, and that said Tract shall be known as IMMIGRANT TRAIL SUBDIVISION REPLAT, the boundary of said tract being more particularly described as follows:

Beginning at the center Quarter corner of Section 30; thence, easterly, on the east-west centerline of said Section, a distance of 379.66 feet to a point on the west Right-of-Way line of U.S. Highway No. 26; thence, a deflection angle right of 56 degrees 59 minutes 58 seconds, on said west Right-of-Way line, a distance of 3056.95 feet to the point of curvature of a curve to the left, said curve having a radius of 2934.8 feet and the central angle of 11 degrees 10 minutes 58 seconds; thence, southeasterly on the arc of said curve, a distance of 572.8 feet to the point of tangency of said curve; thence, a deflection angle right of 74 degrees 12 minutes 00 seconds from the long chord of the last described curve, a distance of 71.13 feet to the point of curvature of a curve to the right, said curve having a radius of 3004.80 feet and a central angle of 11 degrees 25 minutes 02 seconds; thence, a deflection angle right to the long chord of said curve of 105degrees 40 minutes 58 seconds; thence, northwesterly on the arc of said curve and concentric with the west rightof-way line of U.S. Highway No. 26, a distance of 598.76 feet to the point of tangency of said curve; thence, continuing northwesterly, tangent to the last described curve and parallel with the west right-of-way line and U.S. Highway No. 26, a distance of 2350.82 feet; thence, a deflection angle left of 57 degrees 28 minutes 18 seconds, a distance of 700.33 feet to a point on the north-south centerline of said Section 30; thence, a deflection angle right of 90 degrees 00 minutes 00 seconds on said north-south centerline a distance of 636.13 feet to the point of beginning, containing an area of 13.14 acres more or less.

That the accompanying plat is a true delineation of such survey, drawn to a scale of 200 feet to the inch. That all corners are marked with $3/4^{\prime\prime}$ x $36^{\prime\prime}$ iron rods driven well into the ground. That all dimensions are in feet and decimals and that the boundary of the survey is shown on the plat with a heavy solid line.
