

## SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed a tract of land situated in the Northeast Quarter (NE%) of Section Twenty-two (22), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, such tract being more particularly described as follows:

With reference to the Southwest corner of such NE½ of Section 22; then North on the West Line of such NE½, a distance of 1423.94 feet; then a deflection angle to the right of 89 degrees-27 minutes-30 seconds, a distance of 654.32 feet; then a deflection angle to the right of 90 degrees-20 minutes-20 seconds on the extension of and the West Line of the alley as platted in Block 1, Laucomer Addition, a distance of 1424.47 feet to a point on the South Line of such NE½; then a deflection angle to the right of 89 degrees-42 minutes-10 seconds, a distance of 659.55 feet to the point of beginning, containing an area of 21.48 acres.

That I have further surveyed and subdivided such land as above described as "Cleveland Addition, Blocks One (1) and Two (2), including parts of 20th Street, Avenue R and 24th Street therein."

That the accompanying plat is a true delineation of such survey and subdivision, drawn to a scale of 100 feet to the inch. That Block One (1) at the time of this platting is within the corporate limits of the City of Scottsbluff and that Block Two (2) is being annexed to the City. That all block corners are marked with 5/8" x 30" iron rods and that all dimensions are in feet and decimals. That each block bears its own number and that the boundary of the land subdivided is shown on the plat with a heavy solid line with adjoing subdivided lands shown dashed for orientation purposes.
