
# KOA SUBDIVISION 3320

#### SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and prepared a plat of KOA SUBDIVISION, situated in the Southeast Quarter of the Northwest Quarter (SE4NW4) of Section 5, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, and that the boundary of such survey and subdivision is more particularly described as follows:

With reference to the Southeast corner of such Section 5; thence, West on the South line of such Section 5, a distance of 2064.7 feet to the North line of the Right-of-Way of U.S. Highway No. 26; also known as Federal and State Aid Project 300B; thence, Northwesterly, along such Right-of-Way line, a distance of 2556.8 feet; thence, a deflection angle to the right of 47 degrees 50 minutes 00 seconds, a distance of 476.2 feet to the point of beginning; thence, continuing north on the extension of the line last described, a distance of 252.2 feet; thence, a deflection angle to the right of 87 degrees 18 minutes 00 seconds, a distance of 255.00 feet; thence, a deflection angle to the right of 92 degrees 21 minutes 00 seconds, a distance of 24.0 feet; thence, a deflection angle to the left of 49 degrees 53 minutes 20 seconds, a distance of 122.6 feet; thence, a deflection angle to the left of 09 degrees 27 minutes 00 seconds, a distance of 52.0 feet; thence, a deflection angle to the right of 59 degrees 39 minutes 30 seconds, a distance of 150.0 feet; thence, a deflection angle to the right of 92 degrees 36 minutes 45 seconds, a distance of 397.5 feet to the point of beginning, containing an area of 2.14 acres more or less.
