

SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and prepared a Replat of vacated Lot One (1), Block Three (3), George Baltes Addition in the City of Scottsbluff, Nebraska, and that said Replat shall be known as BERGGREN SUBDIVISION AND REPLAT, LOTS 1 AND 2, BLOCK 1, BLOCK 2, and LOTS 1, 2 AND 3, BLOCK 3, the boundary of said Subdivision and Replat being more particularly described as follows:

With reference to the North Quarter corner of Section 14, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska; thence, southerly on the North-South centerline of said Section, a distance of 101.82 feet; thence, a deflection angle right of 98 degrees 57 minutes 30 seconds, a distance of 30.37 feet to the TRUE POINT OF BEGINNING, said point being the point of intersection of the West Right-of-Way line of Avenue B and the South Right-of-Way line of 42nd Street; thence, a deflection angle left of 98 degrees 57 minutes 30 seconds on said West Right-of-Way line, a distance of 608.18 feet to the North Right-of-Way line of 40th Street; thence, a deflection angle right of 89 degrees 38 minutes 00 seconds on said North Right-of-Way line, a distance of 330.00 feet; thence, a deflection angle right of 90 degrees 22 minutes 00 seconds, a distance of 655.26 feet to the point of intersection with the South Right-of-Way line of 42nd Street; thence, a deflection angle right of 89 degrees 40 minutes 00 seconds on said South Right-of-Way line, a distance of 77.47 feet; thence, a deflection angle right of 35 degrees 20 minutes 30 seconds on said South Right-of-Way line, a distance of 20.53 feet; thence, a deflection angle left of 26 degrees 07 minutes 00 seconds on said South Right-of-Way line, a distance of 218.51 feet to the point of beginning, containing an area of 4.82 acres more or less.

That the accompanying plat is a true delineation of such survey and Replat, drawn to a scale of 100 feet to the inch. That all Block corners are marked with $3/4^{\prime\prime}$ x $36^{\prime\prime}$ iron rods and all Lot Corners are marked with $3/4^{\prime\prime}$ x $18^{\prime\prime}$ iron rods driven well into the ground. That all dimensions are in feet and decimals. That each Lot and Block bears its own number and that the boundary of the subdivision is shown on the plat with a heavy
