### SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of a tract of land situated in Southeast Quarter of Section 30, Township 22 North, Range 54 West of the 6th P.M., Scotts Bluff County, Nebraska, and that said tract shall be recorded as Blocks 3 and 4 and Lots 1 thru 9, Block 5, Immigrant Trail Subdivision, a subdivision in Scotts Bluff County, Nebraska, the boundary of which is more particularly described as follows:

With reference to the center Quarter Corner of Section 30; thence, southerly on the North-South centerline of said Section, a distance of 1021.60 feet to the TRUE POINT OF BEGINNING; thence, a deflection angle left of 90 degrees 00 minutes 00 seconds on the South Right-of-Way line of Earnst Street, as previously dedicated, a distance of 803.34 feet; thence, a deflection angle left of 32 degrees 31 minutes 42 seconds on said Right-of-Way line, a distance of 120.42 feet to the point of intersection with the Southwesterly Right-of-Way line of Immigrant Trail Drive, as previously dedicated; thence, a deflection angle right of 90 degrees 00 minutes 00 seconds on said Southwesterly Right-of-Way line, a distance of 354.74 feet; thence, a deflection angle right of 90 degrees 00 minutes 00 seconds, a distance of 168.60 feet; thence, a deflection angle right of 32 degrees 31 minutes 42 seconds, a distance of 953.46 feet to the point of intersection with the North-South centerline of said Section; thence, a deflection angle right of 90 degrees 00 minutes 00 seconds on said North-South centerline, a distance of 325.00 feet to the point of beginning, containing an area of 7.73 acres more or less.

That the accompanying plat is a true delineation of such survey and plat drawn to a scale of 100 feet to the inch. That all Block corners are set with 3/4" by 36" iron rods driven well into the ground. That all dimensions are in feet and decimals and that the boundary of the survey and plat is shown on the plat with a heavy solid line.
