

SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed a part of the Southwest Quarter of the Southwest Quarter (SW&SW&) of Section Thirty-five (35), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, being more particularly described as follows:

With reference to the Southwest corner of such Section 35; then North O degrees-35 minutes-25 seconds East on the West Line of such SW\s\vec{S}V\vec{v} of Section 35, a distance of 486.90 feet to the point of beginning; then continuing North O degrees-35 minutes-25 seconds East on the West Line of such SW\square SW\square, a distance of 140.0 feet; then South 89 degrees-54 minutes-00 seconds East, a distance of 93.91 feet to the P.C. of a 25 degree-48 minute curve to the left, whose Central Angle is 45 degrees-00 minutes-00 seconds and whose tangents are 92.00 feet; then along such curve to the left to its termination; then continuing, tangent to the aforesaid curve, North 45 degrees-06 minutes-00 seconds East, a distance of 100.0 feet to the P.C. of a 10 degree-25 minute curve to the right, whose Central Angle is 45 degrees-00 minutes-00 seconds and whose tangent lengths are 227.99 feet; then along such curve to the right to its termination; then continuing, tangent to such curve, South 89 degrees-54 minutes-00 seconds East, a distance of 30.0 feet; then North 0 degrees-47 minutes-42 seconds West, a distance of 140.0 feet; then North 26 degrees-50 minutes-30 seconds East, a distance of 273.02 feet; then South 0 degrees-17 minutes-30 seconds West, a distance of 498.3 feet to a point on the North Line of the existing alley as platted in Block 23, Northfield First Addition in the City of Gering, Nebraska, according to the recorded plat thereof; then South 89 degrees-54 minutes-30 seconds West on the North Line and the extension of the North Line of such alley, a distance of 149.42 feet to a point on the West Line of 19th Street; then South O degrees-06 minutes-00 seconds West on the West Line of 19th Street, a distance of 25.0 feet to its intersection with the Northerly Line of Kings Road, such point also being the P.C. of a 410.42 foot radius curve to the left, whose initial tangent is perpendicular to the line last described; then along such curve, which is also the North Line of Kings Road, a distance of 322.34 feet to the termination of such curve; then continuing Southwesterly along the Northerly Line of Kings Road, South 45 degrees-06 minutes-00 seconds West, a distance of 100.0 feet to the P.C. of a 362.12 foot radius curve to the right, whose Central Angle is 45 degrees-00 minutes-00 seconds; then along such curve, a distance of 281.41 feet to the termination of such curve; then continuing tangent to such curve, North 89 degrees-54 minutes-00 seconds West, a distance of 93.9 feet to the point of beginning, containing an area of 3.70 acres.

That I have further surveyed and subdivided the land as above described as "Northfield First Addition, Lot Six (6), Block Twenty-three (23) and Lots One (1) through Eight (8), Block Twenty-eight (28)" including parts of streets and alleys therein, an Addition to the City of Gering, Nebraska.

That the accompanying plat is a true delineation of such survey and subdivision, drawn to a scale of 100 feet to the inch. That all corners are marked with iron rods and that all dimensions are in feet and decimals. That each lot and block bears its own number.
