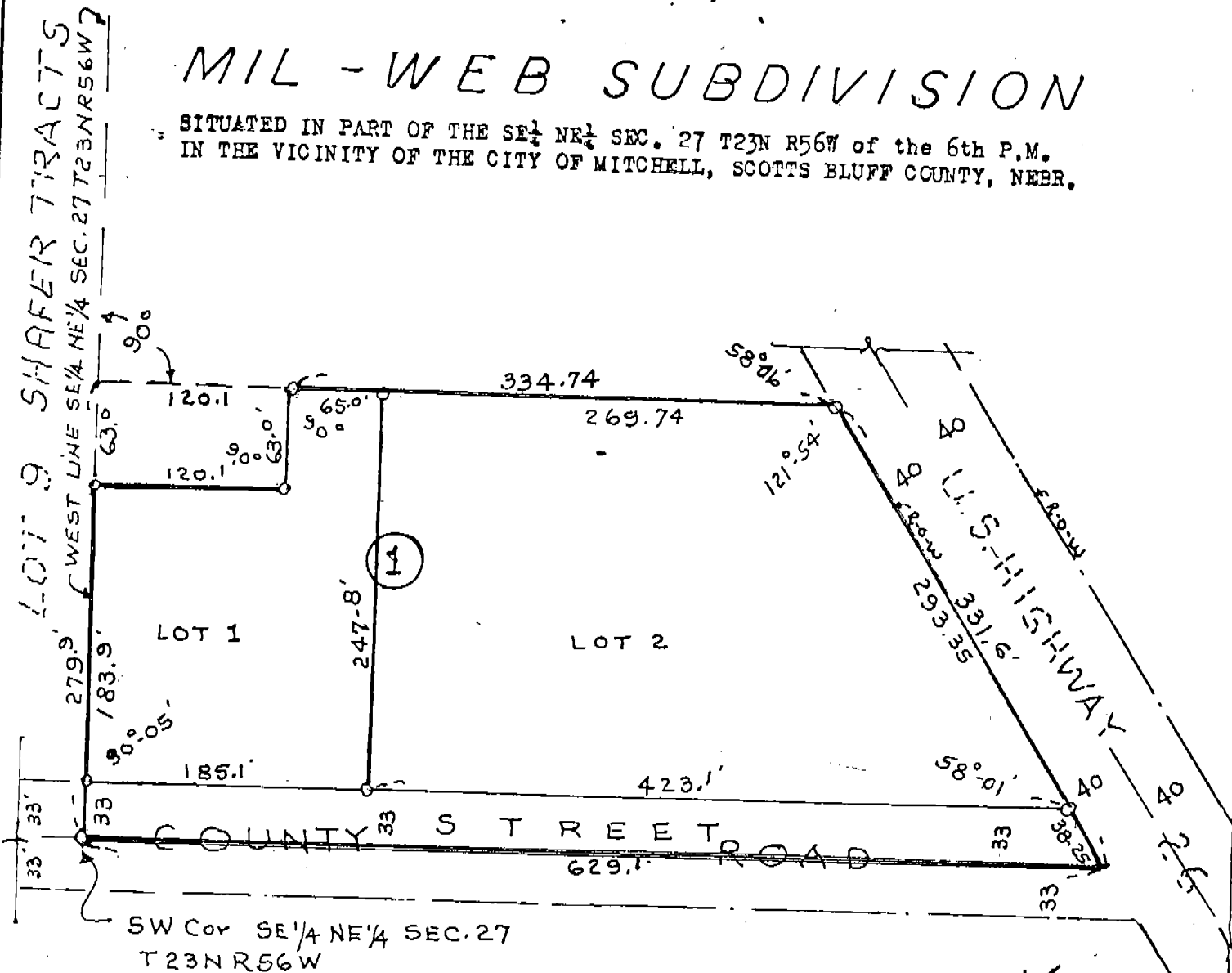

IN THE VICINITY OF THE CITY OF MITCHELL, SCOTTS BLUFF COUNTY, NEBR.



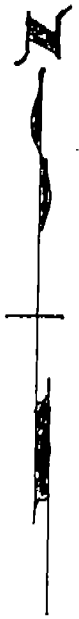

S U R V E Y O R ' S C E R T I F I C A T E

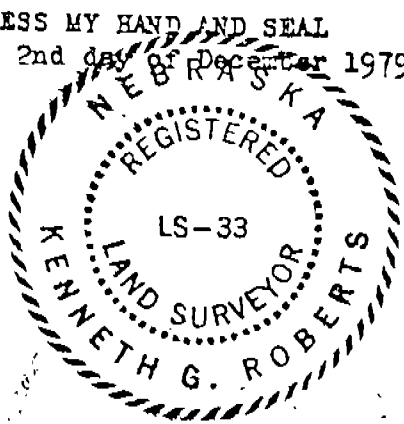
I, Kenneth George Roberts, a Nebraska Registered Land Surveyor L.S. 33, do hereby certify that I have surveyed an irregular tract of land situated in the Southeast Quarter (SE $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$) of Section Twenty-seven (27), Township Twenty-three (23) North, Range Fifty-six (56) West of the 6th P.M., in the vicinity of the City of Mitchell, Scotts Bluff County, Nebraska; more particularly described as follows; BEGINNING at a point on the Southwest corner of such SE $\frac{1}{4}$ NE $\frac{1}{4}$; thence north on the west line of such SE $\frac{1}{4}$ NE $\frac{1}{4}$ a distance of 279.9 feet; thence easterly and perpendicular to such west line of the SE $\frac{1}{4}$ NE $\frac{1}{4}$, a distance of 454.84 feet to intersect the southwest right of way line of U.S. Highway 26; thence southeasterly on such right of way line, a distance of 331.6 feet to intersect the south line of the aforementioned SE $\frac{1}{4}$ NE $\frac{1}{4}$; thence west on such south line, a distance of 629.1 feet to the point of BEGINNING; EXCEPT the north 63.0 feet of the west 120.1 feet thereof;

and have further prepared a plat of subdivision to be known as "M I L - W E B S U B D I V I S I O N" in Scotts Bluff County, Nebraska, containing 3.31 acres m/l

That the accompanying plat is a correct delineation of such survey drawn to a scale of 100 feet to one inch with all dimensions shown thereon in feet and decimals.
 That 1/2" and 5/8" iron rods are driven well into the ground at all lots corners and block corners as shown. That each lot and block bears its own number.
 That the boundary of the subdivision is outlined with a heavy solid line.
