

SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, Nebraska Registered Land Surveyor, hereby certify that I have surveyed a part of the Northeast Quarter of the Northeast Quarter (NE%NE%) of Section Thirty-five (35), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, and in the City of Gering, Nebraska, being more particularly described as follows:

Beginning at the Northwest corner of Lot 1, Block 3, Midtown Development, an Addition to the City of Gering, Nebraska, according to the recorded plat thereof, such point of beginning also being on the Easterly Right-of-Way Line of Nebraska Highway #71; then North 00 degrees-03 minutes-00 seconds East, on such Right-of-Way Line, a distance of 91.8 feet; then South 89 degrees-57 minutes-00 seconds East, a distance of 237.0 feet; then South 00 degrees-03 minutes-00 seconds West, a distance of 66.8 feet to a point on the North Line of Lot 2, Block 3, Midtown Development; then North 89.degrees-57 minutes-00 seconds West, a distance of 37.0 feet; then South 00 degrees-03 minutes-00 seconds West, a distance of 25.0 feet; then North 89 degrees-57 minutes-00 seconds West, a distance of 200.0 feet to the point of beginning, containing an area of 0.49 acres.
