

Stott, a Nebraska Registered Land Surveyor, hereby certify that I have prepared a plat of a strip of land 30 feet in width to be dedicated to the public for alley purposes, said strip being situated in the Southeast Quarter of Section 27, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, the centerline of which is more particularly described as follows:

Beginning at a point on the East line of Lot 30, Bellevue Homes Addition, said point being 15.0 feet North of the Southeast corner of said Lot 30; thence, easterly parallel with the North line of Lot 27, Bellevue Homes Addition, to a point being 15.0 feet, measured at right angles, from the West line of Lot 25, Bellevue Homes Addition; thence, northerly parallel to said West line to a point being 15.0 feet, measured at right angles from the South Right-of-Way line of the Union Pacific Railroad Company; thence, southeasterly, parallel and 15.0 feet distant southwesterly from said Right-of-Way line to the point of intersection with the Northwest Right-of-Way line of Summit Drive, as previously dedicated in Bellevue Homes Addition, said point of intersection being the termination of such alley dedication.


