

SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed a tract of land situated in the Northeast Quarter of Section 35, Township 22 North, Range 55 West of the 6th P.M., in the Village of Terrytown, Scotts Bluff County, Nebraska, and that said tract shall be recorded and known as Block 1, Herber Subdivision, the boundary of which is more particularly described as follows:

With reference to the North Quarter corner of Section 35; thence, southerly on the North-South centerline of said Section, a distance of 202.60 feet to the point of intersection with the North Right-of-Way line of Stable Club Drive; thence, a deflection angle left of 69 degrees 35 minutes 00 seconds on said North Right-of-Way line, a distance of 200.00 feet; thence, a deflection angle right of 08 degrees 24 minutes 00 seconds, on said North Right-of-Way line, a distance of 127.50 feet; thence, a deflection angle left of 28 degrees 40 minutes 00 seconds, a distance of 45.73 feet to the TRUE POINT OF BEGINNING; thence, easterly on an extension of the last described course, a distance of 409.36 feet to the point of intersection with the West Right-of-Way line of Lake Drive; thence, a deflection angle right of 88 degrees 29 minutes 00 seconds on said. West Right-of-Way line, a distance of 192.66 feet to the point of intersection with the North Right-of-Way line of Stable Club Drive; thence, a deflection angle right of 107 degrees 21 minutes 30 seconds on said North Right-of-Way line, a distance of 345.09 feet; thence, a deflection angle right of 12 degrees 55 minutes 00 seconds on said North Right-of-Way line, a distance of 108.30 feet to the Point of Curvature of a curve to the right, said curve having a radius of 25.00 feet and a central angle of 151 degrees 20 minutes 00 seconds, thence, on the arc of said curve, a distance of 66.03 feet to the point of beginning, containing an area of 1.26 acres more or less.

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That the Block bears its own number. That all dimensions are in feet and decimals and that all corners are marked with 3/4" x 18" iron rods driven flush with the ground.
