

SURVEYOR'S CERTIFICATE

I, Robert J. Zumbahlen, do hereby certify that I have surveyed and subdivided a tract of land situated on the South West ½ of Section Sixteen (16), Township Twenty-two (22) North, Range Fifty-five (55) West of the Sixth (6th) Principal Meridian, Scotts Bluff County, Nebraska, such tract being more particularly described as follows: Commencing at the Northwest corner of such South West ½; thence South (an assumed bearing) along the West line of such South Half, a distance of 200.00 feet to the point of beginning; thence South 79°36'07" East, a distance of 722.75 feet; thence South 48°34'07" East, a distance of 292.63 feet; thence South 54°29'31" East, a distance of 428.31 feet; thence South 68°57'56" East, a distance of 183.98 feet; thence South 70°55'05" East, a distance of 312.69 feet, thence South 56°33'48" East, a distance of 384.85 feet; thence South 43°55'20" East, a distance of 276.52 feet, thence South 50°05'44" East, a distance of 135.67 feet; thence South 88°03'12" East, a distance of 299.84 feet; thence South 0°09'16" East, along the East line of the South West ½ of said section, a distance of 190.15 feet; thence North 77°07'45" West, a distance of 0.20 feet; thence North 87°11'05" West, a distance of 367.00 feet; thence North 87°11'05" West, a distance of 367.00 feet; thence North 73°46'40" West, a distance of 579.63 feet; thence North 68°36'00" West, a distance of 229.82 feet; thence North 89°53'15" West, a distance of 866.22 feet to a point on the West line of such South Half; thence North along the West line of such South Half, a distance of 660.80 feet to the point of beginning, containing an area of 21.52 acres more or less.

That the accompanying plat represents a correct delineation of such survey drawn to a scale of 200 feet to the inch; that $1/2" \times 30"$ rebar were set at all corners not shown as found corners; and that all dimensions are in feet and decimals of a foot.


