

## SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of Block 1, Bellingar Subdivision, situated in the South Half of the Northwest Quarter of Section 16, Township 23 North, Range 57 West of the 6th P.M., Scotts Bluff County, Nebraska. The boundary of which is more particularly described as follows:

With reference to the Northwest corner of the South Half of the Northwest  $\frac{1}{4}$  of Section 16 thence easterly on the North line of said South Half a distance of 2,016.40 feet, thence a deflection angle right of  $89^{\circ}-53^{\circ}-31^{\circ}$ , a distance of 599.27 feet to the TRUE POINT OF BEGINNING, thence a deflection angle right of  $91^{\circ}-37^{\circ}-46^{\circ}$ , a distance of 234.39 feet thence a deflection angle left of 910-29'-12", a distance of 632.34 feet to the point of intersection with the North Right of Way line of U.S. Highway No. 26, thence a deflection angle left of 840-06'-10" on said North Right of Way line, a distance of 237.18 feet, thence a deflection angle left of  $96^{\circ}-01^{\circ}-32^{\circ}$ , a distance of 650.54 feet to the point of beginning containing an area 3.46 acres more or less.

That the accompanying plat is a true delineation of such survey and subdivision drawn to a scale of 100 feet to the inch. That all corners are marked with 3/4" X 18" iron rods and that all dimensions are in feet and decimals. That the Block bears its own number and that the boundary is shown with a heavy solid line.
