REPLAT OF ADAMS ADDITION SCOTTSBLUFF, NEBRASKA

SURVEYOR'S CERTIFICATE

I, M.C. Schaff, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed and prepared a replat of ADAMS ADDITION, an addition to the City of Scottsbluff, Nebraska, situated in the South Half of the Southeast Quarter of the Northeast Quarter $(S_{2}^{1}SE_{+}^{1}NE_{+}^{1})$ of Section Fifteen (15) Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P.M., Scotts Bluff County, Nebraska, the boundary of such addition being more particularly described as follows:

Commencing at the East Quarter Corner of such Section 15; thence North along the East Line of Section 15 a distance of 669.0 feet; thence a deflection angle left of 90 degrees 31 minutes 47 seconds, a distance of 50.4 feet to the POINT OF BEGINNING; such Point of Beginning being on the South Line of ADLER TRACTS as previously recorded; thence, continuing along the last described course, and along said South Line of ADLER TRACTS a distance of 1259.9 feet; thence a deflection angle left of 89 degrees 31 minutes 38 seconds, a distance of 509.2 feet to a point on the North Right of Way of U.S. Highway No. 26; thence, a deflection angle left of 90 degrees 29 minutes 08 seconds along such North Right of Way a distance of 1231.0 feet; thence a deflection angle left of 74 degrees 19 minutes 03 seconds, a distance of 110.22 feet to a point on the west Right of Way Line of Highway No. 71; thence a deflection angle left of 15 degrees 12 minutes 10 seconds along the West Right of Way Line of Highway No. 71, a distance of 403.12 feet to the Point of Beginning, containing an area of 14.70 acres, more or less.

That the accompanying replat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all dimensions are in feet and decimals. That all Block corners are marked with 3/4 inch by 36 inch iron rods and that all Lot corners are marked with 3/4 inch by 18 inch iron rods driven well into the ground. That each Lot and Block bears its own number. That the dashed lines shown on the plat are for orientation purposes only and that the boundary of the addition is shown on the replat with a heavy solid line.
