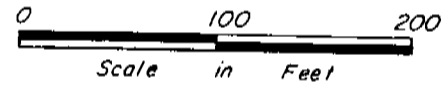


**REPLAT OF LOTS 1, 2, 3, 4, 5, BLOCK 4, TOWN OF HAIG**

SURVEYOR'S CERTIFICATE

I, Duane E.
