


SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed Block 1, KROENING SUBDIVISION, a subdivision of part of Tracts 2 and 3, Shafer Tracts, in the City of Mitchell, Scotts Bluff County, Nebraska, more particularly described as follows:

With reference to the point of intersection of the South line of Tract 4, Shafer Tracts and the West Right of Way line of U.S. Highway #26, now known as Spring Creek Road, thence northwesterly on said West Right of Way line, a distance of 534.25 feet to the TRUE PCINT OF BEGINNING, thence continuing northwesterly on said West Right of Way line, a distance of 329.60 feet to the point of intersection with the East Right of Way line of 10th Avenue in the City of Mitchell, thence a deflection angle left of 149°-22'-30", on said East Right of Way line, a distance of 280.10 feet, thence a deflection angle left of 88°-41'-30", a distance of 167.85 feet to the point of beginning, containing an area of 0.54 acres more or less.

That the accompanying plat is a true delineation of such survey and subdivision drawn to a scale of 200 feet to the inch. That all corners are marked with 5/8" \times 18" iron rods and that all dimensions are in feet and decimals. That the block bears its own number and that the boundary is shown with a heavy solid line.
